Terms & Conditions: ----------→

- 1.) **Qualifying conditions**: Contractor should enclosed following documents along with the quotation;
 - a) Copy of Pan No./GST No./Valid Bombay Shop Act'1948 certificate if applicable
 - b) The agency should have experience of reconditioning, minors repairs and refilling etc. of fire extinguishers in any reputed govt./semi government /reputed Private organization. Value of single order amounting Rs.34,000/- completed in any one of previous 5 financial year should be enclosed along with the quotation.
 - c) Those offers not meeting the above criteria will be rejected.
- 2.) Rates quoted should be inclusive of all taxes and firm quotation basis.

- 3.) No extra charges for transportation, T&P and Labour, material etc will be paid, it will be arranged by you only.
- 4.) You should visit the work site before submitting the quotation.
- 5.) **Payment:** No advance payment will be made.100% payment will be made within 30 days after completion of work satisfactorily subject to availability of funds.
- 6.) Validity of your quotation should be at least 90 days.
- 7.) The work as per orders specification shall be completed within 30 days from the date issue of order.
- 8.) **Security Deposit:** You will have to pay security deposit amounting 5% of the value of the order which will be refunded to you 3 month after satisfactory execution of the order. In the event of unsatisfactory performance of the contract, or non-compliance to T&C this amount will be forfeited.
- 9.) If any loss occurs to MSETCL property during execution of works, you should make it at good at your cost.
- 10.) The income tax & any other tax if applicable will be deducted as per prevailing rate from your bill.
- 11.) MSETCL Company will not be responsible for any accident or damages to any one during execution of works.

- 13.) If any dispute arises, the decision of the undersigned is final & binding on you.
- 14.) Contractor will be responsible for accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing Workman's Compensation Act.
- 15.) **Penalty:** If the contractor fails to complete the work as per order in stipulated time period penalty towards delay @ ½ % per week maximum to the extent of 10% of order value will be levied and deducted from bill for non execution of the work.
