- 4. Ex-works rate & GST Taxes extra should be quoted alongwith HSN code for supply & SAC code for works.

- 8. The fuel (Diesel) charges to be borne by MSETCL with the condition that the vehicle should give minimum 8 Km/Ltr and manufacture of vehicle provided should not be prior to year 2016.
- 9. The responsibility of comprehensive insurance, PUC, Taxi permit & RTO formalities will be with vehicle provider.
- 10. The period of vehicle will normally be one year or amount whichever exhausted from the date of engagement of vehicle, however if MSETCL vehicle is allotted by C.O. Mumbai then the hired vehicle will be discontinued by giving 15 days' notice period.
