  - c. **The offer shall be valid up to 120 days from the date of opening of the quotation/bid**

**2. Place of work – Various Sub-stations and S/Dns under 400KV R.S. O&M DIVISION, DHULE.**  
**“The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive of all Taxes. The taxes should be quoted separately.”**

3. The order value will be limited upto Rs-2,16,255.06/- only including all taxes and the contract period will be one year or till the exhaustion of Order Value.
4. The contractor has to pay 5% of the Order value as a Security Deposit, in FDR/DD/BG before commencing the service. Same will be refunded to the contractor after successful completion of contract.
5. The contractor has to execute the agreement as per the provision of ‘Mumbai Mudrank Adhiniyam 1958, Clause No. 34’ with Rs.500=00 stamp duty before starting of the work.
6. Liquidated Damages / Loss due to theft: - Any damage or loss to M. S. E T. Co. Ltd’s property due to your employees/workers negligence during the course of contract shall be on contractor’s part and same shall be recovered from the bill.
