- 5. Terms of payment: 100% payment will be effected to you, subject to availability of funds.
- 6. <u>Payments</u>: the bills in duplicate should be submitted to this office for payment, with necessary documents as Manual, guarantee / warranty card etc. Addl. EE, HLU Incharge, Mudshingi will certify and record the bills against the supply of material.
