### ANNEXURE (GENERAL TERMS AND CONDITIONS)

- 1) Work completion period: Within 3 months from the date of receipt of the order.
- 2) Work order amount Limited to Rs. 1,00,000/- including all taxes as applicable.
- 3) The interested bidder should submit the offer as per Schedule A at the office of the Superintending Engineer EHV O&M Circle Akola with Seal & Signature along with firm documents such as Shop act, GST, PAN card etc.
- 4) **PENALTY FOR LATE DELIVERY:-** In case the work not completed in time, the bidder shall be liable to pay penalty @ ½ % of the price per week delayed, or part thereof, subject to a maximum of 10% reckoned on the contract value of such complete portion or section of the plant, equipment or material including the portion supplied which could not be brought in to commission due to any part thereof not being completed time.
  - In the event of failure of work execution by the bidder MSETCo Ltd. will execute the works at the cost & risk of the supplier in the open market.
- 5) The quantity mentioned in the schedule A is tentative and may vary during actual execution of work, hence payment will be payable on the basis of supply & execution of actual work. Further, the materials shall be offered of standard make.
- **6) GUARANTEE:-** Works including supplied materials should be guaranteed for a period of 12 months from the date of completion of work.
- 7) **SECURITY DEPOSIT:-** The bidder should pay security deposit at the rate of 5% of the value of the order. Security Deposit is payable by (a) Cheque (b) D.D. (c) FDR (d) Bank Guarantee from a nationalized/scheduled Bank. The SSI units will have to pay security deposit as per statutory provisions.
- 8) Agreement The Contractor will have to enter into an Agreement with the Company to carry out the contract, in the prescribed form on non-judicial court stamped paper of value Rs. 500/- as per the Clause 63 of Mumbai Stamp Duty Act 1958 & amendments there off. Payment will be released by the Superintending Engineer EHV O&M Circle, Akola through cheque within reasonable time period.

Ltd's General Conditions of Contract for the supply of plant, equipment and material particularly in respect of Security Deposits terms of payment, penalty for later delivery etc. And any ignorance of these conditions will not exempt you from your liability to abide by the same.
