- Following documents are required for qualifying in the Techno-Commercial Bids for opening of the Price Bids.
 - a. Name of Bidder, firm, registration of firm with bank details, full address with address proof. (Please attach corresponding scanned copies)
 - b. Valid Bombay Shop and Establishment Act License (Scanned copy is to be attached)
 - c. Registration under GST (if yes Please Attach), if not registered GST will be recovered from quoted rates as per RCM rules
 - d. ESIC registration & last its paid challan (Scanned copy is to be attached)
 - e. Professional Tax registration certificate (Please Attach scanned copy)
 - f. Provident fund registration & last paid challan (Scanned copy is to be attached)
 - g. PAN Card (Scanned copy is to be attached)
 - h. Copies of ITRs filed for last 3 years
 - i. If the bidder is registered in un-employed co-operative society/sanstha, please attach the registration documents
 - j. If the bidder comes in the category of SSI, MSME, attach supporting documents in Technical Bid

2] Techno-Commercial Bid:

Bidder has to submit the rates in SRM for each items as per the guidelines attached for participating in the RFx.

Note:- "The price bid shall not be attached in the document format i.e. by preparing the price Bid and by uploading / attaching the scan copy of the price bid. The same will be not accepted".

A) First the Technical bid will be opened online in respect of all the bids received. The commercial bid will be opened online in respect of those Bidders who have submitted all digitally signed documents/certificates in Technical bid as required in satisfactory manner & who are qualified. If any Deviation is observed in the Technical bid, the same will be informed you on your registered Email ID in the

SRM Portal. You have to submit the compliance / required documents against the same within the stipulated time.

Note :- The Technical bid Documents and the Price Bid for the other bidders participated in the RFx can be viewed by you if required for limited time from the opening of the respective bids.

- B) Right to cancel/alteration any or all the Tender offers without assigning any reason thereof is reserved by the undersigned.
- The rates shall be quoted in the SRM System as per the guidelines attached with the Tender document. The Schedule can be downloaded by the bidder by viewing Print Preview in the RFx.
- D) The rates quoted should be firm and price variation will not be applicable. The offer quoted shall be valid for 120 days. The same is mentioned in the RFx and which is to be accepted by the bidder in the SRM system while participating in the Tender. Also, all the Terms and Conditions of the Tender are to be accepted by the bidder through SRM System while participating in bidding.
 - E) The successful bidder shall have to pay the prescribed security deposit amounting to 5 % of the total value of the contract in the form of B.G./D.D. of any nationalized/Scheduled bank in the name of Superintending Engineer, EHV (O&M) Circle, MSETCL, Panvel, payable at Panvel within 10 days of receipt of work order. The successful bidder shall also execute a stamped agreement at **Division** level at his own cost in the Company's standard forms within a fortnight from the issue of work order.
- F) Bid which do not fulfill all or any of the above conditions or incomplete in any respect are liable to summarily rejection.
- G) The submission of the online bid by bidder implies that he has read these instructions, the conditions of contract, etc. and he had made himself aware of the scope and specifications of the work to be done and conditions. Also rates of factors having bearing on the execution of the work will be provided by bidder.
- H) The MSETCL will not pay any extra cost after acceptance of contract.
- A schedule of quantities is included in the Tender document. Terms of Work:

- 1) Period of contract will be from 01.08.2018 to 31.03.2019. In case the regular staff is posted, the contract will be liable to be terminated after giving due notice.
- a] All the employees should be issued permanent identity cards from agency's end and it should be produced as and when demanded by MSETCL Officers.
- b] The agency will be responsible for compliance of all statutory obligations under the Factory act, minimum wages act, Workmen's compensation Act, contribution under EPF, Professional Tax, CPF Act as applicable in respect of his employees. In addition to all general terms and conditions of MSETCL & State Government applicable for contract labour will be binding of the agency. It will be your responsibility to effect the monthly payment to employee in time. The MSETCL shall not be responsible for any dispute / complaints in this regard.
- c] Duty hours should not be more than 08 hrs per day for a particular employee and will be governed by shops and establishment act 1948 and no overtime will be paid by MSETCL under any circumstances for any extra work / services.
- e] The employee deployed should be polite in behavior. They should be on duty with neat and clean clothes' should be obedient and free from any kind of bad habits. In case anything wrong is found they shall be immediately discontinued.
- f) You will have to provide the permanent and temporary address with photographs of the employees to be deployed under this contract.
- g] The MSETCL shall not be responsible for injury or death of your employee during the course of work. You will be solely responsible for compensation or medical treatments etc. You will discharge all the liabilities arising out of such accident.
- h] This contract does not confirm any right to your employees to be absorbed in company's services.

Terms of Payment

- 1) Payment: Payment will be made by the S.E., EHV (O&M) Circle, Panvel within reasonable time after completion of the work satisfactory in each month and on receipt of your bill in triplicate and certificate obtaining from the In-charge for the work executed.
- 255 Any amount which becomes payable by you to the Company under this contract can be deducted by the Company from any amount or any amount dues on you. The amount of security deposit paid by you will also be adjusted against such payments.
