Sealed and super-scribed quotations are invited for the works as detailed in Schedule 'A' enclosed herewith subject to following terms and conditions.

- 1) **Name of work:** Providing diesel vehicle (TATA Sumo or equivalent) with driver on hire basis for one year for carrying out Hot Line works of EHV lines & sub-stations at Hot Line Unit, Ogalewadi under EHV O&M Circle, Karad.
- 2) The vehicle must be with valid RTO tourist permit and valid for the period of contract, and the vehicle model passing should be after 01/01/2011.
- 3) Only Diesel will be supplied and Toll charges will be paid by the MSETCL.
- 4) The vehicle will be utilized on any day throughout the contract period as per the requirement of undersigned.
- 5) The vehicle will be utilized for works other than Hot line Works, when Hot line work is not possible/scheduled.
- 6) You will have to pay the security deposit of 5% of the order value within Seven days from the date of receipt of firm order.
- 7) The quotations should reach to this office on or before **28.08.2018 up to 16:00 Hrs.**
- 8) Payment will be made per month basis after satisfactory completion of work subject to availability of funds.
- 9) The right to reject any or all quotations is reserved by the undersigned.
- 10) The quotations not confirming to the specifications are likely to be rejected.
- 11) The quotations should be properly sealed and super-scribed on the envelope as "Providing diesel vehicle (TATA Sumo or equivalent) on hire basis for Hot Line works for one year under EHV O&M Circle, Karad."

Note:

- 1) Period of contract: **One year from the date of actual engagement of the vehicle.**
- 2) The average consumption of the vehicle given on hire basis should be 12Kms/Ltr irrespective of actual average of the vehicle. If the average consumption is less, the proportionate amount will be deducted from your bill.
- 3) Only Diesel will be supplied and Toll charges will be paid by the MSETCL.
- 4) The normal duty hours will be from 9.00 to 19.00 Hrs; on every working day. However per day rate will be treated for 10 Hrs; and extra hours will be considered as OT Rs/- per hour; however, either OT or halting charges whichever is less will be paid on a particular day.
- 5) Taxes should be quoted extra if any.
