
1. The Rate shall be quoted on firm quotation basis.
2. The quotation should be sent under sealed cover duly super scribed as QUOTATION of AMC for CTR make NIFPS system for 400/220 kV ICT's at 400 kV R S Kumbhargaoon, Nanded.

3. The price quoted by you in your quotation for supply of the material shall be on firm quotation basis.
4. Your quotation should reach this office **on or before 14.09.2018 up to 13:00 hrs** and the same will be opened on the same day, if possible.
5. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
6. Documents required:- The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
 - A. Valid proof of Shop Act License.
 - B. Valid proof of Electrical Contractor License / Manufacturer / authorized agency.
 - C. Valid Proof of registration under GST.
7. The work shall be completed within 2 to 3 days from the date of receipt of this work order otherwise penalty @ 1% per week subject to max.10% of the order amount will be levied at the discretion of the Competent Authority.
8. The rates offer submitted by you should be valid for at least 60days from the last date of receipt of quotation.
9. Quantity :- Quantity shown in Schedule "A".

10. **Payment:-** 100% payment will be made after receipt of material in good condition at 400 kV R S Kumbhargaoon, Nanded & after receipt of bills in triplicate (Indicating PAN No., GST Reg. No.) to this office through 400 kV Substation Maint. Unit Kumbhargaoon, Nanded for arranging payment. No part payment will be made.

 - a. You have to arrange minimum 2 visits in a year.
 - b. You have to carry out NIFPS trials one for each ICT unit during AMC period.
 - c. You have to carry out inspection & checking of all NIFPS CTR system for each ICT unit.
 - d. You have to attend gas leakage & oil leakages if any observed.
 - e. You have to set the pressure meters of all NIFPS CTR system for each ICT unit.
 - f. You have to check the healthiness of fire detectors & replace if found faulty.
 - g. You need to carry out the work during the scheduled outage availed & A three days prior call will be given by Concern Unit Incharge.
 - h. Deputation of Service Engineer within 24 Hrs, whenever NIFPS CTR system related emergency arises.
15. **Repair services:-** For repair services material utilized should be good in condition & standard make.
16. **Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD/ cheque / Bank guarantee to the office of the Executive Engineer, EHV O&M Div. Nanded from the date of issue of order.
