- 2. Quotation shall be sent under sealed cover duly super scribed as Quotation for providing Computer, laptop & printers at EHV Projects Circle, Aurangabad & Enquiry No. ------
- 3. Quotations received after due date (and time) will not be considered and this office is not responsible for any postal delay.
- 4. Time limit for the work is 1 (one) month. Earlier work completion will be appreciated.
- 5. Total Security Deposit:

Within 7 days from the date of issue of letter of intent/ work order, you will pay security deposit as prescribed in work order in the office of the Superintending Engineer, EHV Projects Circle Aurangabad. The Security Deposit amounting 5 % of work order value in form of cash or Demand Draft or fixed Deposit receipt of Bank Grantee in company's standard proforma. The Demand Draft/FDR shall be drawn in favor of the Superintending Engineer ,EHV Projects Circle Aurangabad by Nationalized / Scheduled Bank.

- 6. The contractor has to pay EMD of Rs 3000/- in cash / In form of DD of any Nationalized Bank in favor of Superintending Engineer EHV Projects Circle, MSETCL Ltd. Aurangabad. The DD of required amount if not found in the envelop the quotation will be rejected.
- 7. Refund of security deposit.

Total security deposit shall be refunded to the contractor in spite of any delay in the finalizing of the final bill within a month from the date of expiry of maintenance period, provided that all works under the contract shall have been completed satisfactorily by the contractor.

- 8. The maintenance period will be of 1 (one year).
