With reference to the above, you are requested to please quote your lowest rate on or before **12/11/2018** up to 11:00 Hrs. stipulated in Schedule "A" (Enclosed herewith) under the terms & conditions laid down hereunder.

Terms & conditions:

- 1) The quotation must be submitted on SRM site <https://srmetender.mahatransco.in> RFX no. **7000010726**
- 2) Following associated documents/Certificates/proof of qualifying pre-requisite etc should upload on SRM site.
 - **ITR, PAN:** PAN No. & Income tax return certificate for last two years.
 - **Shop Act Registration:** Firm's details, Ownership or partnership deed, Attach relevant documents/ Proof of valid registration of firm under Bombay shop & Establishment Act. (If applicable)
 - **GST Registration:** Proof of GST registration. (If not applicable Certificate/ Undertaking accordingly should be submitted).
- 3) **Contract value:** The value of contract is limited to Rs. 2,95,472 /- Lakhs (including all taxes)
- 4) The validity of your offer should be not less than 90 days from the date of submission of offer.
- 5) The taxes like GST will be applicable as per privilege rates & rules circular issued by Govt. time to time.
- 6) **Scope of work:** The scope of work against this contract is as detailed in Schedule 'A'.
- 7) **Signing of Contract:** The agency have to execute an agreement as per provision of "Mumbai Mudarank adhiniam 1958 CL.34" with requisite stamp duty before placing work order. The stamp fees will be borne by Agency.
- 8) **Security deposits:** The successful contractor shall have to deposit the security deposit of 10% of the work order value in cash/ FDR within 7 days from the date of receipt of work order. The same shall be refunded to you after satisfactorily completion of supply of material and as per availability of fund.
- 9) The Undersign reserves rights to add or delete terms during the contract period if found necessary.
- 10) The Undersign reserve the right to place an order for part or to cancel any or all quotations without assigning any reasons.
- 11) **Period of work:** - You will have to complete the work within 45 days from the date of issue of work order.

.) Penalty:

Performance of work: If it is found that performance of work is unsatisfactory, or not as per norms of MSETCL the contract is liable for termination at any stage of work without giving any prior notice and at your entire risk & cost. The security deposit paid by you shall be forfeited in that case.


Delay in execution of work: If the agency fails to complete the work within stipulated time, penalty @ 1% per week, maximum to 5% of order amount shall be levied on contract value. If the work is not carried out in the stipulated period, the works will be got done departmentally or through any other agency at your risk and cost even at higher rates, in addition to the penalty that shall be chargeable as mentioned above.

Penalty for partly completion of work: In case you fail to complete the work allotted to you partly or fully, the balance work will be carried out through other agency and difference in cost will be recovered from your bill and S.D. & the over & above balance shall be recovered from you or else penalty will be charged, maximum up to 5 % of order value whichever is higher.

- 13) **Payment of Bill:** Payment will be made on completion of supply of material and receipt of your Tax invoice to be submitted to this office.
- 14) **Conditions of Contract:** All General / Technical / Commercial terms & conditions of the contract of the company are applicable to this contract & will be binding on bidder.
- 15) The right to modify/ alter /cancel the quotation is reserved by undersigned.
- 16) If the agency has any doubt the meaning of any portion of the E-Enquiry conditions/specifications, he should get it clarified from the office of the undersigned before submission of the offer.
- 17) In case of difference of opinion, about interpretation of terms & conditions between Owner/Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency.
- 18) Any dispute/differences arise will be subjected to jurisdiction of Hon. Nashik court only.
