Sub:- E-Enquiry for Refilling & supply of spare parts of DCP type & Mechanical Foam type Fire extinguishers at Custody Waluj & Administrative Building under Major Store "A" Aurangabad.

Sealed and superscripted Quotations are invited for following enquiry through quotation process of MSETCL from authorized contractors/bidders who are registered vendors of MSETCL for following work as per enclosed schedule 'A', 'B' & 'C' on or before 19.11.2018 up to 13.00 Hrs. with following terms and conditions. Quotations will be opened on this same day at 15.00 Hrs. if possible.

Terms & Conditions:-

- 1) The refilling & supply of part fire extinguishers at custody , Waluj & administrative building under major store "A" Aurangabad will be in force for one year from the date of issue of this order.
- 2) In this period, you should refill & provide spare parts as per rate quoted by you.
- 3) The maintenance of fire extinguisher should be done as per requirement of custody in charge, Waluj.
- 4) Rate should be quoted Exclusive of GST as applicable.
- 5) You should have to pay security deposit @ 5% of the order value.
- 6) The joint inspection on opening of fire extinguisher shall be done in presence of representative of Waluj Custody Incharge .
- 7) The contractor will have to collect the empty cylinder for refilling when required and deliver the same duly refilled at Custody, Waluj & administrative building, Aurangabad . Loss on account of damages/theft during the course of refilling, pressure testing, etc will be recovered from contractor's accounts.
- 8) The contractor should have valid certification under Maharashtra fire prevention of life safety measures act 2006.
- 9) The contractor will have to provide necessary test certificate in support of having tested/refilled the fire extinguishers at the time of delivery otherwise bill not be admitted.

- 10) Income tax and other taxes as applicable will be deducted from your bill at prevailing rate.
- 11) Quotations received after due to date will not be accepted .
- 12) You will have to mention your GST registration number on your bill.
- 13) The spare parts to be provided to fire extinguisher should be new & genuine one, the sample of the same should be got approved from the undersigned. The old spare should be returned to our concerned office in charge & acknowledgement of the same should be enclosed along with the bills.
- 14) All the equipments /material instruments required for refilling of fire fighting equipments at custody waluj & administrative building , T&P ,vehicle etc , & labours shall be arranged by you. No T&P or labour or equipments will be given by the MSETCL .
- 15) The contractor should have experience of similar type of work & should be attached with the offer quotations.
- 16) The contractor will be responsible for accidents to their workers occurring during entire course of work & he will have to pay compensation whatsoever as per the prevailing Workman's compensation act .
- 17) Defective material will be rejected at your own cost and you will replace the same with good one at your cost including cost of transportation if any.
- 18) The payment will be made subject to satisfactory service against submission of bill in triplicate.
- 19) Penalty:- penalty @1/2% per day subject to maximum up to 10% will be recovered from your bill/deposit if you failed to attend servicing/ repairing/ refilling within 7 days from the date of receipt of intimation.
- 20) All expenses towards visit of maintenance engineer shall be borne by you.
- 21) All disputes arising in connections with the above quotation/order will be finalized exclusively in Aurangabad court only.
- 22) The order shall also be governed by general terms & condition of company as amended from time to time.
- 23) If any dispute/ discrepancies arising in the annual maintenance the decision of the undersigned will be final & binding on you.
- 24) The company reserved the rights to accept or reject any or all quotations without assigning any reasons thereof.
