

TERMS AND CONDITIONS

- 1) The estimated rates given by this office are inclusive of taxes. Hence bidder should quote rates inclusive/exclusive of taxes in % only. If bidder quote rate exclusive of tax, then taxes should be quoted separately. The Estimated cost is amounting to Rs.1,79,188/- inclusive of taxes and charges.
- 2) The certified true copy of below mentioned documents should be attached along with quotation.
 - a) Full name and address of the company/ firm. Full name of contractor Permanent address of the contractor/ proprietor of the firm and proof for the same. Proof for registration under ESI Act 1948 with code number of ESI if applicable.
 - b) License for providing manpower on contract basis.
 - c) Proof for registration under Employee's Provident fund with code number, Proof for Professional Tax Number & GST Registration Certificate, if applicable. Full name of the company/firm, Bank name & full address, Bank account number & PAN card copy.
 - d) Proof for registration under Shop & Establishment Act 1948. or NOC of grampanchayat for shop.
 - e) Bank name & full address, Bank account number & PAN card copy.
 - f) Certificate of performance, completion of similar work for amount of 80% of tender amount in MSETCL / MSEDCL / other Govt. utilities by authorities not below the rank of Executive Engineer along with copies of work order.
- 3) S.D. 5% of contract value will have to be paid within 15 days from receipt of the order at EHV O&M Division II Pune

- 4) The age of engaging the persons on outsourcing should be 21 to 40 year.

- 8) The persons should remain present in office from 09.30 to 18.30 Hrs. on working days and shall not leave the office or company representative without prior permission.
- 9) The contractor will be solely responsible for any accidents either fatal or non- fatal occurred to your persons during the course of work, the compensation arising due to this is to be borne by you.
- 10) The contractor is solely responsible for compliance of statutory obligation under shop and establishment act, contract.
- 11) Rate Validity: The rates offer submitted by you should be valid for at least 120 days from the last Date of receipt of quotation.
- 12) PAN no, GST Registration No(if applicable) should be Mentioned specifically in the quotations.
