'TERMS & CONDITIONS '

- 1. The terms and conditions mentioned in the 'Works and Contract 'Book-let are applicable and copies of same can be purchased by the Contractor (s) on payment of Rs. 50.00 from the office.
- 2. The work shall have to be completed in all respect within a period of **15 days** from the date issue of work order, failing which the Contractor will be liable to pay compensation / penalty at Half percent per week maximum up to 10% of the value of the work order.
- 3. The rates quoted by the Contractors shall include:
 - i. All tools and plants required for carrying out the job.
 - ii. All labor charges required to execute the job.
 - iii. All temporary works required to complete the work including transportation of all required material to site.
- 4. The Company shall supply no material. All materials are required to be procured by the Contractor.
- 5. The work shall have to be carried out as per the 'Standard Specifications' and with best workmanship like manner and to the entire satisfaction of the Engineer-in-charge.
- 6. The Contractor shall be responsible for all accidents occurred / damages caused during the execution of the work He shall have to make good of the same at his own cost as directed.
- 7. The Contractor shall be responsible to abide all prevailing labour laws including the Workman Compensation Act.
- 8. The payment shall be made on the Final Bill basis.
- 9. The successful Contractor shall have to pay Security Deposit amounting to 5% of work order

value.

- 10. The quantities in the Schedule 'B' are approximate only and liable for variation.
- 11. The right to reject any or all quotations without assigning any reasons is reserved.
- 12. Any clarification pertaining to work shall be had from the undersigned before submitting the quotation.
