Online bids are invited in two bid system for providing & fixing of sign board size 5 X 3.5sq feet (steel pipe + Panel+ Uco solven vinyle + matt lamination) transportation & fitting included at various substations under EHV O&M Division-I Pune under EHV (O&M) Division-I, Pune on or before 01.01.2019 on following terms and conditions:-

TERMS AND CONDITIONS:-

Submission of bid

Two bid system should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <u>http://srmetender.mahatransco.in</u>

A. Techno –Commercial bid:

This should contain following documents certificates (all self attested copies) as a proof of qualifying prerequisites, broachers, attested certificates etc.

- i) Valid shop act & establishment registration or NOC of Grampanchayat.
- ii) GST registration certificate.
- iii) Copy of PAN card.
- iv) Work experience certificate of similar work executed (not below the rank of Executive Engineer)

<u>If validity of any license/certificate expires during order period, you will have to renew the</u> same & submit the copy to this office. Payment will be affected for valid period only.

<u>B. Commercial bid:</u> Bidder should upload the digitally signed price bid under commercial bid online.

- Techno-commercial bid will be opened online for all received bids. After verifying all the documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tenderer fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
- This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.

• The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.

Terms & Conditions:

1) Validity period should be not less than 120 days from the date of submission of offer.

2) All 220 kV Phursungi substation Incharge is appointed as Operating Officer .

3) Delivery & time Period: The material is to be delivered at each & every substation listed in Annexure 'A' within <u>30 days</u> from the date of final approved sign board by Operating Officer as per Schedule "A" in co- ordination with Operating Officer

4) The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates along with HSN Code exclusive of all Taxes. The taxes should be quoted separately.

5) Security Deposit: - The bidder should have to pay Security Deposit @ of 5% of the total value of the order in this office in Cash/ by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of this order <u>& before supply of material</u>.

If bidder fail to do so, the SD will be recovered from bidders bill. Bidder have to apply for refund of SD within 6 months after completion of validity period of order. If you fail to apply within stipulated period, the action as per MSETCL's rules will be taken.

6) Agreement: You should submit the contract agreement on stamp paper costing Rs. 500/- (Rs. Five hundred only) for this contract before execution of work , the cost of stamp paper is to be borne by you.

7) **Penalty:** If the Bidder fail to supply the material in stipulated time as mentioned above, you will be liable to pay penalty at rate of $\frac{1}{2}$ % per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.)

8) Before supplying the sign boards the sample for sign board should be approved from Operating Officer with prior intimation regarding the date of joint inspection .

9) **Guarantee**: The Material should be of the best & standard quality & as per work order specification. The warrantee of the material must be for minimum one year. You should attend the problems if reported within warrantee period at your risk & cost.

10) The contractor shall not be entitled to claim any interest on amount payable to him related to Security deposit, retentions or any type of payment.

11) You should be fully aware of the M.S.E.T.C.L.'s General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.

12) **Income tax**: If applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.

13) In case of difference of opinion, misinterpretation of any of the condition of the contract, in connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.

14) Any recovery other than mentioned above will be recovered only after agencies consent.

15) After completion of work / supply of material successfully, the agency has to submit the bill alongwith joint measurement certificate singed by both parties.

16) **Jurisdiction**: All disputes, differences related to the tender contract shall be subject to the exclusive jurisdiction of Pune District Court.
