**E-Enquiry**

Sealed and super scribed quotations are invited for work of Attending oil leakages of 400/220kV 315MVA ICT-1 & ICT-2 at 400kV R.S. Division, Talandge as detailed in Schedule 'A' enclosed herewith subject to the following terms and conditions :-

**Name of Work:** - Work of Attending oil leakages of 400/220kV 315MVA ICT-1 & ICT-2 at 400kV R.S. Division, Talandge.

**1. RATES: -**

- a. The rates quoted should be firm in figure.
- b. The rates quoted shall be exclusive of all Taxes, taxes shall be quoted separately.
- c. Current rate of GST is 18% for both material & labour portion.

**2. Following documents needs to be submitted along with quotation**

a) **License:** - Scan copy of valid Electrical Contractor License from competent govt. Authority

b) **Experience Certificate:** - The bidder must have experience for similar type of works i.e. attending of oil leakages of ICT's , during last 5 years (from scheduled date of submission of E- Enquiry) and having

▶ One similar completed order not less than the amount equal to 80% of the E- Enquiry amount OR

▶ Two similar completed works not less than amount equal to 50% of the E- Enquiry amount OR

▶ Three similar completed works not less than the amount equal to 40% of the E- Enquiry amount.

▶ For all above works contractor shall submit the experience from an authority not below the rank of Executive Engineer in case of MSETCL/MSEDCL/MSPGCL or govt. organization and in case of Private organization/company certificate shall be from manager or equivalent post.

c) **Goods & Services Tax Registration:** - Scan copy of valid GST registration Certificate

d) **Bombay Shop Act:** - Scan copy of valid Bombay Shop Act Registration certificate

e) **I.T. Return:** - Scan copy of Income Tax Return to Income Tax Department for the Financial Years 2015-16 and 2016-17 (i.e. A.Y. 2016-17 and A.Y.2017-18)

f) **Net Worth Certificate:** - Net worth Certificate only from Charter Accountant for year F.Y. 2016-17 & 2017-18.

g) **Turn Over Certificate:** - Turn over certificate from Chartered Accountant for year F.Y.2016-17 & 2017-18.



### **3. AWARDING OF CONTRACT: -**

The company does not bind itself to award the contract to the lowest bidder. Eligibility of the bidder, submission of all documents & past record etc. will carry due weightage while arriving at the decision. The decision of the Dy. Manager (F&A) & Executive Engineer 400kV R.S. Talandge on deciding lowest bidder will be binding on the contractor.

### **4. SIGNING OF CONTRACT: -**

The successful bidder shall execute an agreement bond on stamp paper of Rs.500/- in prescribed format within 15 days from date of receipt of work order. Cost of the Stamp paper to be borne by contractor. Until the agreement is executed, MSETCL will not be liable to pay, nor shall contractor be entitled to claim amount due or payable under the contract.

### **5 ORDER VALIDITY: -**

Order will be valid for a period of 12 months from date of order.

### **6 ACCOMODATION:-**

Residential facility will not be provided by MSETCL.

### **7 SECURITY DEPOSIT: -**

The successful bidder should pay security deposit of 5% of the order value by cash/Bank Guarantee/Demand Draft within 15 days from date of receipt of order in the office of Superintending Engineer EHV O&M Circle Kolhapur. The security deposit will be refunded after successful completion of work & guarantee period. No interest will be paid on security deposit. In case of Bank Guarantee, it should be valid up to the period of guarantee period.

### **8 TAXES & DUTIES: -**

Income Tax and Work Contract Tax (WCT) as applicable will be deducted from the bills. Similarly, any other taxes deductible at source, if applicable to this particular contract, as per statutory provisions (laid down by Central or State Government) will also be deducted from the bills at the prevailing rates.

**All the taxes, duties, levis and cess whatever name it called will be effective at prevailing rate.**

### **9 WORK COMPLETION PERIOD: -**

The work shall be completed within the outage period from handing over of site/equipment.

### **10 SCOPE of WORK: -**

1) Attending of oil leakage of 400/220/33kV 315 MVA ICT-1 from LV B-phase OLTC cover, Tertiary tank, Main buchholz relay, Group 'B' pump meter, Radiator pipes, also visible oil leakage from all other points of ICT-1 wherever required & as per instructions of site incharge.

2) Attending of oil leakage of 400/220/33kV 315 MVA ICT-2 from HV R-ph Turret cover, Tertiary tank near neutral bushing, CTR pipe valve at main tank, Radiator pipes valve, also visible oil leakage from all other points of ICT-2 wherever required and as per instructions of site incharge.

**Note that all tools & plants shall be arranged by contractor .**

### **11 BILLS And PAYMENTS: -**

- a. Bills in triplicate shall be submitted to the office of Executive Engineer, 400kV R.S. Division Talandge on satisfactory completion of work along with work completion certificate.
- b. 100% payment will be made against bill after recording & availability of funds.
- c. GSTN No should be printed on bill.



**12 OUTAGE: -**

Executive Engineer 400kV R.S. Dn. Talandge will arrange for outages required for execution of work subject to permission of L.D. Kalwa & system conditions. Contractor will have to take necessary written permission/permit of Engineer In-charge before starting the work.

**13 PENALTY: -**

- a. If the contractor fails to carry out the work within time limit as per terms & conditions clause no (09) above, then penalty at the rate of ½% per delayed day shall be applicable subject to maximum 10% of order value.
- b. In case of failure to carry out the work during the contractual period, MSETCL will have liberty to get the work done departmentally or from other agency at the cost and risk of the agency.
- c. If any loss or damage occurred to the MSETCL property, the same shall be borne by contractor during the course of work. The amount of damage/loss will be recovered from the bills/security deposit and any other Bills from entire MSETCL.

**14 GUARANTEE: -** The entire work should be guaranteed for **1 year** from the date of completion of Work. The work carried out by contractor if found defective due to bad manufacturing/workmanships, the same work shall be replaced by contractor free of cost, if reported to him within guarantee period

**15 ACCIDENT: -**

MSETCL will not be responsible for any liability arising out of accident or any other eventuality during the working. The entire liability as per the rules and regulation in respect of personnel engaged under this contract will be resting on the agency.

**16 IDLE LABOUR HOURS: -**

In case of suspension of work, or delay in work due to any reason or stay order of the Court of Law no compensation will be paid by the Company for idle labours /idle machinery etc., during the period.

**17 WORKS AND SAFETY REGULATIONS: -**

The contractor shall ensure the safety of all the workmen/labours, and equipments either belonging to him or to others working at site.

**18 SAFETY EQUIPMENTS: -**

Contractor shall provide all safety equipments such as electrical safety shoes, helmets, rain coat etc. to his labours going to deploy against this SRM Enquiry.

**19 SUB LETING OF CONTRACT: -**

Sub letting of the contract will not be allowed otherwise the contract will be terminated and the security deposit shall be forfeited.

**20 TERMINATION OF CONTRACT: -**

The undersigned reserves the right to accept or reject the contract in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 07 days, if it is found that the contractor is not able to cope up with or



discharge duties satisfactorily / or not able to execute the work as per Order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.

**21 FORCE MAJEURE:** - Following conditions shall be considered for this clause

- a. Natural phenomenon such as floods, draughts, earth quakes, epidemics etc.
- b. Act of any government domestic or foreign, such as war (declared or undeclared), priorities, guarantees, embargoes etc.
- c. Party affected by 'Force Majeure' shall within 15 days of the occurrence of such a cause, notify MSETCL in writing with sufficient documentary proof.
- d. In case of damage or destruction of any property or equipment belonging to contractor due to force majeure cause, MSETCL shall not be liable for the same.

**22 APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** -

Notwithstanding anything stated herein, the MSETCLs General Terms and Conditions of Contract applicable to the contract, shall be applicable this contract also.

**23 JURISDICTION:** -

All disputes or differences arising under / out of or in connection with this order shall be subject to exclusive jurisdiction of Kolhapur court only.

**24 DISPUTE:** -

In case of any disputes, the decision of the undersigned will be final & binding on the contractor.

**25 First Aid Box:-** The contractor should always keep & maintain First Aid Box for this work as safety court only.

**27** The successful contractor will have to abide by more rules as deem fit by the concerned authority. The instructions to the contractor shall form part of contract.

**28** The undersigned reserves the right to reject the quotation without assigning any reason thereof and will not be bound to accept the lowest one not to assign any reason for the rejection of quotation.

**29** The undersigned reserves the right to accept or reject any or all quotations without assigning any reason thereof. Also the RIGHT to add/ alter/ modify/ relaxing/deleting of any of the conditions of this SRM Enquiry is reserved by the undersigned if required in favor of MSETCL at any time.

**30** All other term & conditions of services prescribed by MSETCL from time to time will be applicable to this enquiry also.

**31** The quotation should reach this office on or before 04.01.2019 upto 17:00 Hrs,postal /courier delay will not be entertained.
