With reference to the above, please offer your lowest rates for the work of

"AMC for hiring of crane services at various Sub-stations, Maintenance Sub-Divisions under EHV O&M Division, Dhule to the terms and conditions mentioned as under.

1. The Quotations giving full particulars should reach this office on before 08.01.2019 up to 13.00 Hrs. positively.

Place of work – Various Sub-stations and S/Dns under EHV (O&M) Division, Dhule.

"Note that Contractor cannot claim transportation charges between various locations (Sub-station to sub-station). Bill will be paid on Actual work hours measurement & not on Minimum hours of work per day."

"The bidder should quote rate exclusive of GST. The taxes should be quoted separately."

2. Following documents are required with quotation:

1	Full name of quotation submitting firm & full address of the same.					
2	Contractors name, permanent address & Address Proof.					
3	Valid shop act & establishment registration/grampanchayat NOC as applicable.					
4	Full name of quotation submitting firm, Bank name, bank address, bank account details, PAN No. Should be submitted.					
5	GST Registration Certificate. If not applicable then undertaking regarding that.					
6	Experience of providing regarding crane services in MSETCL or MSEDCL. Experience Certificate is essential of competent authority.					

Failing to submission of above said documents will lead to reject the offer

If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office. Payment will be effected for valid period only.

- a. This office reserves all the rights to reject any or all bids without assigning any reasons thereof.
- b. The offer shall be valid up to 120 days from the date of opening of the quotation/bid
- 3. The contractors will have to bear GST applicable from time to time by the Government.
- 4. The order value will be limited upto 3 Lakh only including all taxes and the contract period will be one year or till the exhaustion of Order Value.
  - 5. The crane driver provided by the contractor shall be free from any bad habits like smoking, drinking etc and should be well convergent and having sufficient experience.

- 6. The normal working time for the crane, on the required day, will be from 07:00 Hrs to 19:00 Hrs. However in case of emergencies, the crane have to spared by the contractor before or after the stipulated time as per the instructions of Executive Engineer, EHV O&M Div.Dhule or its representatives i.e. incharge of various Sub-stations or S/Dns.
- 7. The said Crane should not be owned by MSETCL company employee/his nearest relatives.
- 8. Driver should be managed by Crane owner. He should have valid license to drive such type of Crane & has experience for driving such type of Crane.
- 9. The contractor will be intimated 12 Hrs. in advance whenever the crane is required. However in case of emergencies, no prior notice can be given, and the contractor have to arrange the crane immediately whenever told by the Executive Engineer, EHV O&M Div.Dhule or its representatives i.e. incharge of various Sub-stations or S/Dns.
- 10. The crane provided by the contractor should be provided with all necessary crane belts, its binding material etc.
- 11. The crane fuel (diesel/petrol) and lubricants to be borne by the crane provider. This office will not provide the same in any case. The Crane should be always in good and maintain condition.
- 12. If in case, the crane fails or stops working in the middle of the work, the contractor has to immediately provide another crane suitable for the work.
- 13. The necessary maintenance to be carried out and the cost of the same to be borne by the contractor only.
- 14. The contractor has to pay 5% of the Order value as a Security Deposit, in cash / DD before commencing the service. Same will be refunded to the contractor after completion of contract.
- 15. The contractor has to execute the agreement as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with Rs.500=00 stamp duty before starting of the work.
- 16. Liquidated Damages / Loss due to theft: Any damage or loss to M. S. E T. Co. Ltd's property due to your employees' negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
- 17. Work should be carried out as per the directives of Executive Engineer, EHV O&M Div.Dhule or its representatives i.e. incharge of various Sub-stations or S/Dns.
- 18. Agency should submit **GST** Registration and other relevant registrations.
- 19. The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during The course of contract. Contractor will have to provide safety equipments to his employees.
- 20. Contractor will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The MSETCL shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.

  - 22. Instructions given by sub-station/ Sub.div. incharge regarding work in Live Switchyard should be strictly followed by Contactor.

- 23. **If any type accident occurs, whole responsibility shall be of Contractor. MSETCL** shall not be responsible for that.
- 24. The disputes, if any, shall be subjected to the jurisdiction of the **Dhule** Court only.
