- 2. Delivery: The time being essence of the contract, supplier should strictly adhere to the delivery period as per schedule 'A'. The delivery will be deemed to have been completed on the date of R.R./on the date of receipt of material at major stores Osmanabad. A postal transit period of 7 days will be allowed from the date of issue of order.
- 3. Penalty for late delivery: In case the material are not delivered in time, penalty @ 1/2 % of the price per week delayed will be levied, subject to maximum of the 10% of the contract value.
- **4.** Specifications: The materials offered should strictly confirm to the specifications. Wherever asked for, the necessary test certificates must accompany the consignment. If necessary, the material will be tested before /after delivery to ensure that it confirms to the specifications. If the same is not confirming, then the whole lot will be liable for rejection.
- **5.** Sample of Electrical rubber hand gloves & discharge rod as per applicable standard & specification should be approved by the Executive Engineer EHV Project Division, Nanded OR his nominated representative not below the rank of Additional EE before Delivery.
- **6.** Payment of Bills:- Suppliers will be paid 100% payment of the contract price along with 100% taxes as applicable of each consignment by A/c payee cheques Or by NEFT/RTGS(In case of such request from agency) against delivery. The bill should be submitted to this office in triplicate, accompanied by the S.R. Note of consignee, test certificates (if any), and advance stamp receipt.
- 7. INSURANCE:-In all cases the insurance shall be affected by you with Government Insurance Fund for the total value of the order plus 10% to cover freight, GST and other incidental charges.
- 8. CONSIGNEE:-The Executive Engineer, EHV Project Division, Nanded OR his nominated representative not below rank of Additional Executive Engineer.
- 9. You will be deemed to be fully aware of the Company's General conditions of contract for the supply of plant, equipment and material particularly in respect of Security Deposits, terms of payment, penalty for later delivery etc. And any ignorance of these conditions will not exempt you from your liability to abide by the same. - 10. Material Received at store should be in good condition, Party should have to transport all the material at their own Risk & cost.
- 11. TERMINATION OF ORDER:- Failure to execute the order in time/as per specifications, or any breach of the condition of the contract will result in termination of the contract, without prejudice to the other recourse available under the law of the land.
