- 1) <u>Due Date</u>: The quotations complete in all respects, dully sealed & super scribed should be submitted to this office on or before dt. 07.02.2019 upto 17:30 Hrs.
- 2) **Quoted Rates**: The quoted rates should include the cost of material, transportation also the loading & unloading charges etc. No extra charges for transportation, T&P, labour, packing, insurance, excise, material etc will be paid.

3) Documents required:

- a) PAN/ TAN registration certificate.
- b) Valid GST registration certificate.
- c) Proof of firm being registered as shop establishment/firm/ Company as applicable.
- d) W.O. & Experience certificate for execution of same type of work i.e. P&F of breather along with Silica gel in MSETCL.
- 4) **Validity of offer**: The offer should be valid for our acceptance for period of 120 days from the last date of submission of offer/ quotation.
- 5) **Quantity of supply**: The material should be supply as per specification mentioned in schedule 'A'. MSETCL will not accept the items with different specification. If material not received in good condition, the same shall have to be replaced in part or in whole as per case.
