
**TERMS & CONDITIONS:**

- Scope of work:** The said work should be carried out in accordance with the particulars and description enlisted in the enclosed **Schedule-B**.
- The rates should be inclusive of all works, tasks, studies all other Subsidiary or Complementary Statutory clearances from the required statutory authorities, all taxes, levies, duties, Insurance, etc. to obtain the Approval of Diversion of Forest Land.
- The Contractor should furnish following details along with online bid.
  - Experience of similar nature of work from MSETCL/MSEDCL/GOVT/Semi Govt,
  - GST Registration certificate,
  - Registration of firm under Bombay shop
  - Income Tax returns of last three financial years (e.g. Year 2015-16, 2016-17 and 2017-18)
  - PAN,TAN
- Taxes will be applicable as per rule.
- 5% Security Deposit is to be deposited in Cash/Crossed DD/Cheque before commencement of work. The same shall be refunded to you after the satisfactorily Completion of the work.

6. Income tax will be deducted as per prevailing rules from the bill & a certificate to that effect will be issued to the contractor.
7. The Contractor will have to execute the work as per scope of work mention in the schedule in all respect within six months from the zero date i.e handing over of tower schedule etc. failure of such; penalty equal to ½ % per delayed week subject to the maximum of 10% of the ordered value will be levied.
8. The time stipulated in the contract for the completion of the work shall be deemed to be the Essence of the Contract. The Contractor shall so organize his resources and perform his work as to complete the work within stipulated time period.
9. The Contractor shall have to make his own arrangements for travelling boarding, lodging etc to the site including visit to office of DFO, RCCF, PCCF office, etc and any/all other govt. offices pertains to above job, the cost of which should be included in price bid.
10. The Consultant is to report progress of work to the Addl Executive Engineer, S&I S/Dn MSETCL Nasik on weekly basis and obstruction if any shall be reported immediately to work out a solution thereof. Timely processing & grant of Forest Diversion Proposal from Forest authority, Govt. of India under F.C.Act,1980 is the essence of the contract.
11. The payment will be effected as per stage of the forest approving authority as per actual quantities only.
12. The Consultant shall depute only competent, qualified and sufficiently experienced personnel to perform the work correctly and efficiently.
13. The Consultant will provide required copies of properly bound documents and reports as required under Forest Conservation Act, Wild life protection Act, FRA, 2006, Environment Protection Act , R&R Policy and other allied Acts, Rules, Notifications and guidelines etc. for submission to Forest Department, Maharashtra, MSPCB and MOEF for obtaining Forest and Environmental Clearances including extra copies required to be sent to the members during compliance. The consultant will also provide all reports in soft copies (on External Hard Drives and CDs/DVDs).
14. The contractor will be abiding by the Rules & Regulations in force in respect of his employees & workmen under the Workmen's Compensation Act & the Contract Labor Act etc. He should be a registered contractor & documentary evidence of the same should be produced.
15. As per provision of 'Mumbai Mudrank Adhinyam, 1958 clause No.34' an agreement on appropriate value of stamp paper shall have to be executed with MSETCL for execution of contract satisfactorily before commencing work. The amount of the fees for such an agreement shall be borne by contractor.
16. Right to accept any or to reject any or all the quotations without assigning any reasons thereto is reserved by the undersigned.
17. The quantities enumerated in attached Schedule 'B' are approximate & payment will be made against actual executed quantities.
18. The rates quoted should be valid for 60 days.
19. Idle charges for any reason will not be accepted.
20. Not contained herein all other terms and conditions of MSETCL will be applicable to this enquiry
21. In case of any dispute regarding this contract, the jurisdiction of the court will be Nashik.


