

- 4) Offer- Quotation in sealed envelope should be supercribed with the above referred enquiry Number or Name of material
- 4) Rates - Rates should be firm and of the foresaid destination.

- 7) Payment - Payment will be released within 30 days against final system SAP, No advance payment will be released against dispatch document
