EXTENSION NOTICE E-Enquiry

Subject: - EXTENSION NOTICE Enquiry for Supply of New Safety Helmets, Safety Belts & Electrical Rubber Hand Gloves as per specifications & applicable IS standards at 400KV Receiving Station Division Khadka.

Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your lowest rates for the above work. The terms and conditions are as follows.

TERMS AND CONDITIONS

- 1. Due Date:** - The quotation complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dt. 05.03.2019** up to **15:00** Hrs Positively.
- 2. Scope of work :-** As detailed in schedule ' A '
- 3. Quoted Rates:** - The quoted rates should include the cost of material, all skilled and unskilled labour and also the requisite T & P, incidental charges etc. The Taxes will be clearly mentioned, & if the Taxes are not clearly mention, then it will be considered as Inclusive of all taxes.
- 4. Validity of Offer:** - The offer should be valid for a period of 180 days from the date of the work order.
- 5. SPECIFICATIONS:-** The materials offered should strictly conform to the specifications as per Schedule A . Wherever asked for, the necessary test certificates must accompany the consignment. If necessary, the material will be tested before / after delivery to ensure that it conforms to the specifications. If the same is not conforming, then the whole lot will be liable for rejection.
- 6. Approval of Sample:** - At least 1 No. of Sample of Electrical Rubber Hand Gloves, Safety Helmet & Safety Belt as per applicable standard & specification should be approved by the Executive Engineer 400kV RS Dn. Khadka before delivery.
- 7. Delivery Period:** - You will have to deliver the total material 30 Days from the date of approval of sample.
- 8. Security Deposit:** - The successful contractor shall have to deposit the security deposit @5% of contract value towards security deposit in this office by Cash/DD/B.G./FDR before commencement of the work. The same shall be refunded to you after satisfactorily completion of work and Guarantee period as per availability of funds.
- 9. Agreement:-** An Agreement is required to be executed by the person with the companies on stamp paper of Rs. 500/- containing all the terms and conditions of the order before its execution as per Mumbai Stamp Duty 1958 Clause No. 63.
- 10. Supervision Officer:-** The work shall be supervised by the Executive Engineer or his representative and it should carry out to the satisfaction of Engineer in charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 11. Submission & Payment of Bills –** You should have to submit the Original bill in Triplicate to this office under the name of undersigned along with Guarantee/Warrantee Certificate, Test certificates if required etc. After that 100% Bill payment will be paid to you by account

- payee Cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per Bill Certified by Dy.E.E. (O) 400 kV R.S.Khadka-Bhusawal.
12. Please quote your PAN No. and GST No. on your quotation/Bill, otherwise, Taxes as per rules will be deducted from your bill.
 13. **Taxes:-** According to the financial Act 194 (C) of 1972 Income tax & 1% Labour Cess will be deducted from your Bill at the applicable rate of the contract value and certificate to that effect will be issued to you.
 14. **Document required:** - The offer rate must be accompanied with following documents.
 - I. Firm Registration copy or Shop Act establishment Copy.
 - II. Valid GST Registration Copy if applicable.
 - III. PAN Card Xerox.
 - IV. Work order copies/Performance certificate issued by authority not below the Rank of Executive Engineer of similar type of works such as supply of any type of safety equipments as a proof of experience.
 15. Undersigned reserved the right to accept any quotation or to reject/ accept all the quotation without assigning any reason. For any dispute/differences arised, that will be subjected to jurisdiction of Bhusawal court only.
 16. **PENALTY FOR LATE DELIVERY:** - In case the materials are not delivered in time, the supplier shall be liable to pay penalty @ ½ % of the price per week delayed, or part thereof, subject to a maximum of 10% reckoned on the contract value of such complete portion or section of the plant, equipment or material including the portion supplied which could not be brought in to commission due to any part thereof not being delivered in time. The penalty will be levied subject to **force majors'** conditions, for which documentary evidence will have to be produced to the satisfaction of the competent authority of the Board. In the event of failure to supply, our Company may purchase the ordered materials at the cost & risk of the supplier in the open market.
 17. MSETCL Reserve rights to add more terms during the contract period if found necessary.
 18. Agency should have to pay **Rs. 100** against enquiry Quotation Fees by cash to this office & copy of receipt attached with quotation.
