TERMS & CONDITIONS

- 1. Scope :- The vehicle shall be "TATA Indigo/ TATA Zest /Swift Desire/ Desire/ Honda X-cent etc, The vehicle should Taxi permit be available for 24.00 Hrs
- 2. **Rates:-** Rates shall be quoted on per day basis; along with mileage KM/Ltr. The order will be limited to Rs 40,000/- per month or as specified from time to time, whichever is higher, inclusive of fuel.
- 3. Taxes :- Rate should be quoted Exclusive of taxes.
- 4. Normal working hours shall be from 9.00 Hrs to 21.00 Hrs. However, these timings may vary in emergency work.
- 5. **U**tilization of taxi on holidays will be option to the Company. As such, payment will be made only for the days on which the vehicle is actually utilized by the Company.
- 6. **N**o wages, dearness allowance, overtime, halting charges or any other charges will be paid for any reasons to the Driver by the Company.
- 7. In case, the fuel is supplied by the Company, account will be maintained by the Officer incharge. Company will not provide for Oil, Lubricants or any other repairs for material charges, incidentals etc.
- 8. If, the vehicle becomes sick while in use for unreasonable time period (to be decided by the (Company) the charges will be proportionately deducted/ or alternative vehicle should be made available at the same rates.
- 9. The vehicle should have valid taxi permit/ registration, road taxes and insurance premium paid Covering all types of risk and the P.U.C. certificate as per the law in force from time to time by the R.T.O. Authorities. All documents to be submitted by the contractor.
- 10. Income Tax return of the last year
- 11. The taxi owner whose taxi is hired will have to park the taxi in Company's premises or in his taxi shed in Yavatmal at his own risk.
- 12. In case, the taxi is parked outside the Company's premises, the vehicle run will start and end at Company's Office / Local parking place at Yavatmal
- 13. The driver of the taxi vehicle should have valid driving license and will follow prescribed parking signals speed, time etc. as per the traffic rules and R.T.O. rules in force.
- 14. If desired, the driver will have to sign the vehicle diary maintained for vehicle by the Company.
- 15. Incidental repairs if required while in use will be carried out by the driver at your own cost. However, if the charges are paid by the Company, same will be recovered from your bills.
- 16. The vehicle will be used by any Officer of the Company if nominated by the Addl. E.E. (C) / EHV CCCM S/Dn. No. Yavatmal.
- 17 Toll tax / Parking charges will be paid by the company extra

- 18. The taxi will be hired on day-to-day basis during the period from 01.04.2019 to 31.03.2020.
- 19. No extra charges will be paid if the vehicle is required to be stayed out of station.
- 20 .If, offers of two different agencies are received for the vehicle of same number, the offer of both the agencies will be treated as cancelled.

21.The work order value for hiring charge including GST+ all other taxes and excluding cost of fuel will be limited to 3,00,000.00 (Rs. Three Lakh Only).

22. Rs. 3000.00 will have to be deposited to this office at the time of submission of quotation, as Earnest Money Deposit, in the form of Cash which will be refunded after execution of the order. If after placement of order, taxi is not provided on hire basis then the amount of Rs. 3000.00 will stand forfeited. The amount will be refunded to those whose quotations are not considered for placing order.

- 23.Conditional offer will not be accepted.
- 24. Model of the vehicle should be latest and in any case it should not be more than 5 years old as on March-19
- 25.All rights are reserved with the undersigned.
- 26.The successful agency will have to pay S.D. Amounting 5% of the work order value within 15 days from the issue of the letter of intent.
- 27. The successful agency will have to enter into an agreement with the company for this work on Rs. 500.00 stamp paper within one month from the issue of the work order until such agreement is executed. The company shall not be liable to pay nor you shall e entitled to claim any amount due for payment if any, under this contract.
- 28. The quotations will be issue to the agencies who is registered with the MSETCL as a vendor.
- 29. Quotations should be submitted to this office on 13.03.2019up to 13.00 Hrs. and will be opened on the same day, if possible. Quotations should be submitted in the sealed envelope, super scribed on the envelop "Quotations For Hiring of Vehicle" shall be mentioned. The Quotations submitted without Earnest Money Deposit are likely to be rejected.
- 30.Terms of payment: Payment will be made directly in your bank account on monthly basis as per rules by this office after submission of bills in triplicate to this office.
- 31.Income Tax as per rules will be deducted from your bills.
- 32. After awarding the contract if it is observed that the services rendered by the Taxi owner / Driver is not to satisfaction of Officer in- charge , the contract will be terminated as per the general conditions of the contract of M.S.E.T.C.L.
- 33. In case of any accident the entire responsibility will be of the Taxi owner only. No claim on this account will be entertained by the Company.
- 34. The vehicle may be used any where in <u>Maharashtra State</u> under the jurisdiction of the Company.
