- 2) **Scope of Work:** Work of providing & fixing of distilled water plant at various sub-station under EHV (O&M) Division, Dhule as per Schedule "A".
- 3) **Quoted Rates:** The rates quoted are including of all taxes, charges, labour cess or any other local charges etc. Please mention GST separately.
- 4) **Security Deposit:** The successful bidder will have to pay an amount equivalent to <u>10 (Ten) %</u> of Contract value towards S.D. at Executive Engineer, EHV (O&M) Division, Dhule within 15 days from the date of receipt of work order which is refundable after satisfactorily complication of guaranty period.
- 5) **Validity of Offer:** The offer should be valid for our acceptance for a period of 6 month from the due date of same.
- 6) **Delivery Period:** Distilled water plant should be delivered within two months from date of W.O. at various S/S under EHV (O&M) Division, Dhule. as per **Annexure "A".**

# 7) <u>Guaranty: You should give guarantee of the work done and Material supplied against</u> this order must be guarrented for best performance at least for 12 (Tweleve) months from the date of work done.

8) **Technical skilled persons:-** The contractor shall depute skilled workman for each class work.

9) Specifications of Distilled water plant as follows:

Capacity of distillation 4 Litter / Hour

Material of construction: Stainless Steel

Heater: 3.0 KW

- 10) **Document Required:** The rate offer must be accompanied with following documents by vender:
  - I) Full name of quotation submitting firm & full address of the same.
  - II) Contractors name, permanent address & Address Proof.
  - III) Bank name, bank address, bank account details, Copy of PAN card Should be submitted.
  - IV) Valid shop act & establishment registration/grampanchayat NOC as applicable.
  - V) Valid GST Registration Certificate. If not applicable then undertaking regarding that.
  - VI) Valid Electrical Contractor license.

VII) Order copies along with Experience certificate issued by competent authority not below the Executive Engineer of similar type of works in MSTCL / PGCIL / MSEDCL.

- 11) Stacking of material:- The material will be stacked at one place, you should take all precautions for watch & ward. Also, the replaced material, if any, may be handed over to S/S incharge & submit the statement along with certificate.
- 12) **Packing/Forwarding:** Packing/Forwarding will be at the cost of the contractor.
- 13) **Income Tax:** Income tax will be ducted at per rules.
- 14) The Work order contract may be placed of partial/full quantity of work mentioned in this enquiry.
- 15) **Dispatch Instructions:** The transportation of any kind of material are in the scope of Agency.
- 16) **Payment:** 100% payment shall be made after successful completion of work order & to our satisfaction at EE EHV (O&M) Division, Dhule.
