Terms and conditions:-

- 1) **Scope:** - The vehicle shall be sedan class diesel Taxi i.e. "Maruti/Hundai/Honda/Verna etc; latest model. The vehicle will run throughout Maharashtra State (Particularly in Vidharbha region). The vehicle should be available for 24.00 Hrs. The vehicle registration should be within five years i.e after March-14.
- 2) **Rates:** - Rates shall be quoted on per day basis.
- 3) **Amount of work order will be limited to 3 lakhs only.**
- 4) **Payment:** - 100% payment shall be effected by A/c payee cheque or RTGS subject to availability of fund on monthly basis for which you will have to submit the bills in triplicate.
- 5) **Taxes:** - Rates should be quoted exclusive of taxes.
- 6) **Other Charges:** - All RTO formalities shall be to your account. The cost of lubricant, spares, driver charges, halting charges, over time charges, maintenance charges of vehicle etc will be on your account. Toll Tax/Border tax/Parking charges will be paid by company extra.
- 7) **Model of the vehicle** should be latest and in any case it should not be more than 5 years old as on March-19.

- 8) During duty period of hiring, all risks, and any accident traffic penalties will be on your account and the insurance liability will be on your part.
- 9) The vehicle should have taxi permit.
- 10) Quotations to be submitted on the agencies letter pad as per the above table format with signature.


11) Agreement:

As per rules of Maharashtra State Electrical Transmission Company Ltd., you shall execute a stamped agreement in respect of this contract within a period of two weeks from the date of issue of work order. The cost of stamp paper etc. for the agreement shall be borne by you. No payment shall be made to you under this contract till such time the agreement is executed by you.

- 12) All the valid documents related with your vehicle must be submitted with quotation duly attested. The list of required document is as below
 - RC & TC books of vehicle offered.
 - Fitness certificate of the vehicle.
 - Insurance certificate covering all types of risk.
 - Registration certificate/ Rout permit of transport contractor.
 - Pollution under control certificate.
 - Income tax return of the last year.
 - Diver having valid driving license.
 - GST registration certificate, if applicable.
- 13) If any shortfall or wrong documents as above, the quotation will be considered as invalid and will not be accepted for further comparison. Please note.
