(A) Techno Commercial Bid (Part-I) :

This should contain following documents certificates (all self attested copies) as a proof of qualifying pre-requisites, brochures, attested certificates etc.

7	Average annual financial turnover during the last 3 financial years ending 31 st March of the previous financial year should be at least 60% of the estimated cost. In support of this the bidder shall submit the annual audited report certificate by statutory auditor in case of company & by the Chartered Accountant where accounts are not required to be audited under any law

(B) Price Bid (Part-II) :

Bidder should upload the digitally signed price bid.

- Techno-commercial bid will be opened online for all received bids. After verifying all the documents /certificates submitted in techno commercial bid for prequalification as mentioned above. If it is found that the tenderer fulfills the desired prerequisites; the price bid will be opened online. If the same is not found as per the prerequisite, the commercial bid will not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc., are liable to reject the offer completely. The declaration or undertaking related to non uploading / submission of valid documents is not allowed.
- **This office reserves all the rights to reject any or all offers / bids without assigning any reasons thereof.**

- It is important to bring to the notice of all the bidders that **“The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately. In case, if both technical & commercial bid are uploaded in one file wrongly, the offer will be straight way rejected”**.
- **The offer shall be valid up to 90 days from the date of opening of the tender.**
- The estimated rates given by this office are inclusive of all taxes. However, the bidder has to quote rates exclusive of all Taxes. The taxes have to be quoted separately along with HSN / SAC code (GST codes) for individual items & it is mandatory for all bidders.

Instructions to the Tenderers :

1. Security Deposit: The contractor has to remit, Security Deposit @ of 5% of the total value of the order in this office in by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of the work order and before starting the execution of the work as per work order. The amount of the Security Deposit will be refunded to you after successful completion of the Guarantee Period & if applied within six months from the date of completion of the work as per work order as well as after obtaining no dues certificate / No objection Certificate from all concerned SSI .

2. Earnest Money Deposit (EMD): Each tenderer / bidder will be required to pay the earnest money deposit of **Rs. 5,000/-** before the due date / time of opening of the technical bid. Request for exemption from earnest money deposit will not be considered on any grounds.

The EMD is liable to be forfeited if the bidder / tenderer refuses to accept the order placed during the validity period.

Note: Earnest money deposited will be refunded online through SRM System after approval from the competent Authority. EMD will be credited to the bank account maintained by the bidder in vendor Profile in SRM system. **Bidders are requested to ensure that the bank details; i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address etc. are correctly maintained in SRM System and update the same, if required.**

It may be noted that:

- 1) In case bank details are not maintained by the bidder in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay or any other conflict related to the said issue.
- 2) MSETCL will not be responsible for any financial implications in case if incorrect bank details are maintained by the bidders; as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD.

Above Note is incorporated in the Tender Documents to ensure successful refund of EMD to the eligible Bidders and to avoid any legal complications.

3. Validity of the Tender: Tender shall remain open for acceptance for a period of **30days** from Starting date for submission. During this period, no bidder shall be allowed to withdraw his tender. Any such withdrawal during the said period will be entitled for the forfeiture of the earnest money deposited (EMD) by the tenderer / bidder. **However, the offer submitted by the bidder must have a validity of minimum 90 days from the last date of submission of offer.**

4. Acceptance of the Tender: The Company does neither have any binding on itself to accept the lowest or any quoted offer nor have binding to specify / inform about any reason be assigned for the rejection of any or all bids. It is also not binding on the Company to disclose any analysis report related to subjected tender or rejection of bids.

5. Discarded to Tender conditions: The Company reserves the right with itself to reject the tender.

6. Validity of order: The period of the contract shall be of three months from the date of issue of the work order/ LOI .

7. Work Completion Period: - The work should be completed within Three Months from the date of issue of the work order/ LOI .

8. Warrantee: You will have to give the warrantee of work executed by you up to period of 12 months from the date of work completion. Defects developed during warranty period should be rectified at the cost of contractor.

9. Agreement:-The agreement should be executed on Rs.500/- Bond paper & cost of agreement to be borne by agency, if applicable

10. Penalty: If the contractor fail to supply the material in stipulated time as mentioned above, he will be liable to pay penalty at rate of ½ % per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.

11. Supervision:-The Executive Engineer EHV O&M Division-I Pune or his representative will supervise the work as per MSETCL standard.

12. Quality of Work & Material:-You will be responsible for quality of work & workmanship. The material used is to be strictly as per specifications given by Executive Engineer EHV O&M Division –I Pune.

13. Termination of contract: The undersigned reserves the right of cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect or undue delay in execution of work / starting of the work.

14. Applicability of general conditions of contract: Notwithstanding anything stated herein, the MSETCL's General Terms and Conditions of Contract shall be applicable to the contract, as far as they are applicable to this contract also. If the bidder is not aware of the same, he/she may ask this office or may visit to MSETCL website to know about the same.

15. Before starting the work the material should be approved from undersigned.

16. Failure of Execution of the work: If the agency fails to complete the work as per given Schedule against the order in full, within the stipulated period, the Company shall be at liberty, without giving further notice or reminder to the contractor, to get the same supply of Material on account of and at the risk of the contractor. MSETCL will prefer a claim for the difference in price and for all expenses whatsoever incurred in getting the same supply of Material. The said claim shall be recovered from any payment due to the Contractor, i.e. from bills or deposit or on any account; such expenses will also include 15% Supervision charges.

17. In case, if the work is not executed partly or fully, the balance work will be got from some other agency even at higher rate and difference in cost will be recovered from your pending bill with the Company or Security Deposit will be forfeited in addition to above.

18. Acceptances of contract work: The work against this contract will be subject to the approval of the undersigned or any other officer deputed for the purpose. He is at liberty to reject any or the whole work without assigning any reason and his decision in respect of such rejection will be final.

19. Tax Invoice : The tax invoice should be submitted to the Addl. Executive Engineer Line Maintenance S/Dn-I, Pune as per Schedule 'A'. The bills must be submitted along with joint measurement certificate signed by both parties, warrantee certificates etc. Service entry of the work executed will be done by Addl. Executive Engineer Line Maintenance S/Dn-I, Pune. After receipt of the bills from the Addl. Executive Engineer Line Maintenance S/Dn-I, Pune, auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds.

20. Price Variation:- Please note that the clause related to price variation is not applicable to this work order in any case.

21. Recovery: - Recovery other than mentioned above will be recovered after consent of both parties.

22. Electricity & Water supply :- Electricity & water will not supplied by MSETCL.

23. Conditions of tender and contractor: The tenders and orders / contract placed against this specification shall be governed by the Company's General Conditions of contract, the tenderer / agency is deemed to be fully aware of these conditions and ignorance thereof shall not exempt him from his liability to abide by these conditions. The enclosed schedule, tender notice, tender form and instructions to tenderers also form a part of this specification.

24. In case of any dispute whatsoever, regarding interpretation of the terms and conditions, or quality, the decision of the Executive Engineer, EHV O&M Division I Pune will be final and binding on the contractor.

25. Whenever any recovery towards losses/damages/shortages etc. is applicable; the same shall be recovered from your bill, as assessed by the Operating officer / Engineer-In-Charge.

26. Income Tax : Income Tax will be deducted from the contractor's bill.

27. All other Standard Terms and conditions prescribed by MSETCL, regarding supply and work, which are not stated here, are also applicable to this contract.

28 Jurisdiction: All disputes, differences related to the tender contract shall be subject to the exclusive jurisdiction of Pune District Court.

29. Sub- Letting of Contract: The contract or any part thereof shall not be assigned, transferred, or sublet without the prior written permission of the undersigned. Even if such permission is granted, it shall be responsibility of the principal contractor to whom the work order originally issued to execute the works as per the terms of the contract.

30. Force Majeure: Only the following conditions shall be considered for the purpose of this clause.

- a. Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc.
- b. Acts of any Government, Domestic or Foreign such as war (declared or undeclared) Priorities, Guarantees Embargoes etc.
- c. The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause notify the MSETCL in writing with sufficient documentary proof.

31. The provision made in various Acts in force applicable to this contract is obligatory on the Contractor while executing the work.

32. The contractor shall always keep and maintain in order First Aid Box at site as a safety measure for the labours.

33. Due date of Tender: All the tenders received up to the due date and time will be opened as far as possible on the specified date and time. In case of urgency of work on the specified date or any connectivity & website related problems, same will be opened on next working day.
