TERMS AND CONDITIONS :

- 1) The quotations should reach to this office on or before **16/05/2019 upto 16.00 Hrs.** This office shall not accept any responsibility for late receipt of quotations due to postal delay.
 - a) **Rate :** The rate quoted shall be on firm basis and shall be inclusive of All taxes excluding GST.
 - b) All the taxes including wheel tax, town duties, comprehensive insurance and any other statutory tax applicable. (However the incidentals such as parking charges, toll/ entry tax etc will be borne by the user).
 - c) The services of the Driver.
 - d) Only Diesel shall be supplied by MSETCL.
 - e) The normal working duty of the vehicle is from 09.00 to 19.00 hrs or 08.00 to 18.00 hrs as fixed by vehicle incharge with one hour recess period for the Driver.
- 2) **Vehicle / Registration :**
