
1. The Rate shall be quoted on firm quotation basis.

3. The price quoted by you in your quotation for supply & erection of the material shall be on firm quotation basis.
4. Your quotation should reach this office **on or before hrs 22.05.2019 up to 16:00 hrs** and the same will be opened on the same day, if possible.
