- 1) Validity period should be not less than 120 days from the date of submission of offer.
- 2) Work completion Period: The work is to be within 3 month after receipt of work order
- 3) Supervision of Work:-The work shall be under the supervision of Additional Executive Engineer Hot Line Unit under EHV O&M Circle.Pune
- **4)** Taxes:-The estimated rates given by this office are inclusive of GST. However, the bidder should quote rates exclusive of GST. The taxes should be quoted separately.
- 5) **Security Deposit**: You have to remit, Security Deposit @ of 5% of the total value of the order in this office in Cash/ by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of order. If you fail to do so, the SD will be recovered from your first bill with interest. Also, you will have to apply for refund of SD within6 months after completion of guarantee period. If you fail to apply within stipulated period, action as per company's rules will taken
- 6) The T&P/labour/ machinery/ equipment/ material required for the work shall be on your account.

- 7)**Penalty**: In case of failure to complete the work in stipulated time as mentioned above, you will be liable to pay penalty at rate of 1/2% per week subject to maximum limit of 10% of the total values of the order.
- 8) Warrantee: The work done should be of the best & standard quality & as per schedule enclosed. The work should be warranted for minimum one year. You should attend the trouble if reported within warrantee period at your risk & cost.
- 9) **Accident**: The contractor shall ensure the safety of all the workmen, materials and equipment at work site. The contractor shall be responsible for providing of all safety notices and safety equipment required. If any accident occurs to any person, labour skilled or unskilled, compensation if any, is to be paid by the contractor only.
- 10) Any breakage/damage occurred to MSETCL material/ Equipment / theft of material if any, asset during the work shall be recovered from your bills as per rules.
- 11) The contractor shall not be entitled to claim any interest on amount payable to him.
- 12) You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereof to any third party. In case any deviations observed it will be treated as breach of contract and the contract will be terminated at your entire risk and cost.
