- 2. Quotation should be duly filled in all respect otherwise it will not be considered.
- 3. The time period for transportation of material is 15 days from the date of handing over of site/material.
- 4. If the contractor fails to carry out the work in full or in part, the work will be got carried out from other party even at higher rates and the difference in rate will be recovered from contractor.
- 5. If transportation is not completed as per stipulated period penalty will be charged as per Company Rule.
- 6. Permission to transport from RTO/PWD & other, if necessary, should be obtained by you
- 7. The vehicle used should be of adequate capacity certified by RTO & insured by insurance authorities.
- 8. Octroi: If any shall be paid by the contractor & same shall be reimbursed on production of receipts in original, however escorts etc. shall be borne by the Contractor.
- 9. You will have to pay Security Deposit @10% of the order value in favor of MSETCL towards due performance of the contract.
- 10. The bidder should have experience of similar work (i.e. experience of transportation of electrical equipment or tower)The experience certificate thereof should be enclosed.
- 11. Updated/ renewed copy of shop Act license, GST Registration, experience certificate, PAN car copy should be enclosed with quotation.
- 12. If order get placed on you, you will have to submit the following updated document of vehicle before transportation:
 - a) document of ownership of vehicle
 - b) vehicle registration.
 - c) Fitness certificate of vehicle
 - d) Insurance copy etc
- 13. Labour for works will be on your account. Required man power and machinery is to be arranged by you. No material labour, transport facility shall be supplied by company. RTO formalities shall be fulfilled by the contractor. Vehicle required for execution of the work will not be

provided by the MSETCL. It will be the entire responsibility of the contractor to provide required T&P necessary for execution of the work.

- 14. In case of any dispute decision of the Executive Engineer, EHV Projects Dn-1, Pune shall be final and binding on the agency.
- 15. Right to reject any or all the quotations without assigning any reasons thereof are reserved to undersigned.
