- 3. QUOTED RATES: The rates quoted shall be inclusive of cost of material/labor charges (whichever is applicable), transportation, material & requisite T&P required for execution of work, lodging boarding, incidental charges, etc. The condition for taxes shall be mentioned clearly in price bid. If nothing is mentioned regarding taxes, it will be treated as rates quoted are inclusive of all taxes
