- 2. The supply should be carried out as per latest PWD standard specifications & as per enclosed Schedule B & as directed by Engineer-In-charge to the full satisfaction.
- 3.Quantities mentioned in Schedule "B" are approximate and are liable for variations. However, payment shall be made as per actual quantities executed and measured as per M.S.E.T.C.L.'s rules.
- 4. Old Exide make Inva Master Tubular Batteries (6 Nos.) are to be buyback by bidders. Agencies have to visit office to check those batteries to quote the buyback rate before quoting the rates.
- 5.E-enquiry should be duly filled in all respects and signed, failing which it will be liable for rejection.
- 6.In case of any dispute, decision of the Superintending Engineer (C) MSETCL, EHV CCCM Circle, Kolhapur shall be final and binding on the contractor.
- 7. Rates quoted shall be exclusive of all the Taxes.
- 8.Income Tax, as per prevailing rates will be recovered from your bill.
- 9.No any material will be issued by the Company for this work.

- 10. Other contractual terms and conditions of MSETCL shall be applicable to this contract also.
- 11. You have to quote your offers considering prevailing rates of GST. If the contractor is registered in GST, it is contractors responsibility to pay the GST to appropriate Government authority. In case of GST unregistered contractor, GST as per prevailing rate of bill amount will be recovered from the bill and same will be directly paid by this office to Government authority.
