- 3. Completion Period: You will have to carry out the said work for 12 months from the receipt of the work order or intimation to you by Executive Engineer or his representative.
- 4. Payment: Monthly RA Bill payment will be paid to you by account payee Cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per Bill Certified by Add.E.E.(Maint.) 400 KV R.S.Div Babhaleshwar
- 5. Please quote your PAN. No and GST No. on your quotation /Bill, otherwise, Taxes as per rules will be deducted from your bill.
- 6. For any accident of your staff, public and MSETCL staff while carrying out the work; you will be responsible for any compensation etc.
- 7. If any damage occurs to the company's property during execution of above work, contractor will have to make them good at his cost.

- 14. The work will have to be carried out for one year from this office intimation otherwise penalty at ½ % per week subjected to maximum 10% of the ordered amount will be levied at the discretion of competent authority.
- 15. Quantity mentioned in schedule 'A' are tentative and payment will be made on the basis of actual quantities executed by you.
- 16. The work shall be supervised by the Add. Executive Engineer, appointed by under signed and it should carry out to the satisfaction of Engineer, in charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 17. The workers employed by you for the above work shall not be entitled for any facility/claim from MSETCL what so ever.
- 18. The work should be carried out on day to day basis as per instruction from Addl. E.E. (Maint) 400kV RS Babhaleshwar. Failure to carry out the work satisfactorily penalty as per rule per day shall be levied at the discretion of the competent authority.

The agency will be required to remove the said person & suitable replacement will be provided Immediately within 24 hours by the agency at no extra cost.

- 20. MSETCL bears no responsibility of any kind in r/o the worker employed for this work & Contractor shall be whole responsible to observe & follow all the statutory provisions regarding Labour laws. The rates should be quoted considering applicability of all these aspects.
- 21. MSETCL Reserve rights to add more terms during the contract period if found necessary.
