TERMS AND CONDITIONS:-

1. The Rate shall be quoted on firm quotation basis.
2. The quotation should be sent to undersigned under sealed cover duly super scribed as QUOTATION FOR Hiring of vehicle i.e. Tata Sumo / Mahindra Bolero or equivalent with driver for Addl.EE, Testing Unit I Nanded under Testing Division Nanded (Enquiry No. _____ be quoted).
3. Your quotation should reach this office on **or before 19.06.2020 up to 17:00 hrs**. The quotations will be opened on the same day, if possible.
4. Quotation received after due date will not be considered. This office will not be responsible for any postal delay.
5. Documents required:- The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
 - a. Vehicle Registration Certificate
 - b. Vehicle Tourist/Taxi Permit
 - c. Driver with Valid Driving license
 - d. Valid Vehicle Insurance
 - e. Valid PUC certificate
 - f. Vehicle Fitness Certificate
 - g. Vehicle Model should not be more than 3 year old
 - h. Valid PAN No. & GST registration certificate
 - i. Valid shop act registration certificate
6. No extra charge will be paid for vehicle driver, oil & other taxes & duties etc. Only Toll tax will be paid by MSETCL.
7. An agreement has to be signed with MSETCL regarding abiding with all the terms and conditions of the work on a non-Judicial stamp paper of Rs.500/- if work is allotted to you. Stamp paper charges will be born by you.

8. The fuel (Diesel) charges to be borne by MSETCL with the condition that the vehicle should give minimum average of 12Km/Ltr and manufacturing date of vehicle provided should not be prior to year 2017.
9. The responsibility of comprehensive insurance, PUC, Taxi permit & RTO Formalities will be with vehicle provider.
10. The period of vehicle will normally be for one year from the date of engagement of vehicle, however if MSETCL vehicle is allotted then the hired vehicle will be discontinued by giving 15 days notice.
11. Security Deposit:- Security deposit i.e. 5% of order value to be paid after issue of work order but before actual deployment of vehicle to the office of the Executive Engineer, EHV (O&M) Division, Nanded from the date of issue of order. The same will be refunded after satisfactory completion of this contract. If you fail to execute the order in full or part security deposit will be forfeited.
12. Payment will be effected on per month basis within reasonable period & availability of funds.
13. Quotation submitted along with all necessary vehicle documents duly self-attested. No conditional quotations are allowed.
14. The rates should be quoted inclusive/exclusive of all taxes. If nothing is mentioned about taxes, the rates will be treated as rates inclusive of all taxes.
15. The vehicle will operate in Parbhani/Nanded/Hingoli District, However, vehicle may be used for occasional official tours to other district places if required, for which no charges shall be paid extra.
