

The S.D. will be refunded after satisfactory completion of the work / guarantee period subject to NOC from concern officer.
- 4.** You will have to submit the bills in triplicate with duly certified & recorded by AEE 400 kV Substation Maint Unit K'gaon, Nanded at 400 kV R S Division Kumbhargaoon, Nanded.
- 5.** 100% payment will be made against receiving of bills to this office and as per availability of funds.
- 6.** The quotations should reach to this office on or before **18.08.2020 up to 13.00 Hrs.**
- 7.** The quotations not confirming to the specifications are likely to be rejected.


