- 3. Quantities mentioned in schedule "B" are approximate and are liable for variations. However, payment shall be made as per actual quantities and measured as per M.S.E.T.C.L's rules.
- 4. E-enquiry should be duly filled in all respects and signed, failing which it will be liable for rejection.
- 5. In case of any dispute, decision of the Executive Engineer, EHV Projects Division Kalyan shall be final and binding on the contractor.
- 6. Rates quoted shall be inclusive of all the Taxes.
- 7. Income Tax, as per prevailing rates will be recovered from your bill.
- 8. You have to quote yours offers considering prevailing rates of GST. If the contractor is registered in GST, it is contractors responsibility to pay the GST to appropriate Government authority. In case of GST undersigned contractor, GST as per prevailing rate of bill amount will be recovered from the bill and same will be directly paid by this office to Government authority.

Successful agency have to pay total security deposit 5% of value of the contract by Cash within 7 days from the date of issue of order, in the office of the Executive Engineer, EHV Projects Division Kalyan, otherwise same will be recovered through bills. Same will be refined after successfully completion of contract period.
- 10. Agreement As per the rules of MSETCL successful bidder will have to enter into an agreement on stamp paper of amount of Rs. 500/- with MSETCL for the above work as early as possible. An until such agreement is executed with the MSETCL, the MSETCL shall not be liable to pay nor the successful bidder shall be entitled
