TERMS AND CONDITIONS:-

- 1. The Rate shall be quoted on firm quotation basis.
- 2. The quotation should be sent under sealed cover duly super scribed as QUOTATION Supply of various switchgear spares Relay's, MCCBs & contactors for 400kV & 220kV Bay Control and Relay panels at 400 kV R S Division Kumbhargaon, Nanded. (Enquiry No. ____ be quoted).
- 3. The price quoted by you in your quotation for supply of the material shall be on firm quotation basis.
- 4. Your quotation should reach this office on or before 15.02.2021 up to 17:00 hrs and the same will be opened on the same day, if possible.
- 5. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
- 6. Documents required:- The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
 - A. Valid proof of Electrical Contractor License.
 - B. Valid proof of manufacturer / authorized dealer / distributor.
 - C. Valid Proof of registration under GST.
 - D. Valid Proof Shop Act registration.



- 7. The material shall be supplied within 45 days from the date of receipt of this office order otherwise penalty @ 1% per week subject to max.10% of the order amount will be levied at the discretion of the Competent Authority.
- 8. The rates offer submitted by you should be valid for at least 90 days from the last date of receipt of quotation.
- 9. **Delivery:** The time being essence of the contract, the supplier should strictly adhere to the delivery period as per schedule 'A'. The delivery will be deemed to have been completed on the date of receipt of material at 400 kV R S Kumbhargaon, Nanded. A postal transit period of 7 days will be allowed from the date of issue of order.
- 10. **Quantity:** Quantity shown in Schedule "A". The order value will be limited to Rs. 2,97,887.39/- only (including all taxes/duties).
- 11. **Specifications:-** The materials offered should strictly conform to the specifications. Wherever asked for, the necessary test certificates must accompany the consignment. If necessary, the material will be tested before / after delivery to ensure that it conforms to the specifications. If the same is not conforming, then the whole lot will be liable for rejection.
- 12. Sample:- Sample of Switch, Relay & Contactor as per applicable standard & specification should be approved by the Executive Engineer 400 kV R S Division Kumbhargaon, Nanded Or his nominated representative not below the rank of Additional Executive Engineer before delivery.
- 13. Payment:-100 % payment will be made after receipt of material in good condition at 400 kV Testing Unit K'gaon, Nanded & after receipt of bills in triplicate (Indicating PAN No., GST Reg. No.) to this office along with test certificates (if any), and advance stamp receipt for arranging payment. No part payment will be made.
- 14. Paying Office:- The payment against this contract will be effected by Executive Engineer, 400 kV R S Division Kumbhargaon, Nanded within reasonable time as per funds availability.
- 15. **Insurance:** In all cases the insurance shall be affected by you with Government Insurance Fund for the total value of the order plus 10% to cover freight, GST and other incidental charges.
- 16.Please quote your **PAN & GST No**. in the quotation & provide **HSN code** for material to be supplied.
- 17. **Delivery Period :-** The material is to be delivered at 400 kV R S Kumbhargaon, Nanded within 45 days from date of firm order.
