- Guarantee Period: The material should be warranted by company for One year or as per Manufacturer warranty from the date of installation against any manufacturing defects & will be replaced in case of defect arises in the warrantee period, should be replaced free of cost.
- 3) Delivery Period: The work should be supplied within 15 days from the date of issue of supply order to this office.
- 4) Penalty: If you fail to supply the material in time, penalty at 1% per week or part thereof will be levied on you on the cost of material which are supplied late subject to maximum 10% of the total value of the this order, However due consideration will be given in lieu of penalty for the reasons absolutely beyond your control which documentary evidence will have to be produced by you.
