Online bids (on % basis) are invited in two bid system for the work of Weed Control chemical Treatment & Rodent control treatment for 3 quarters at various substations under EHV O& M Division-I, Pune on or before 24.11.2021 upto 10:00 Hrs. on following term and conditions:-

TERMS AND CONDITIONS:-

Submission of bid

Two bid system should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in>

A. Techno –Commercial bid:

This should contain following documents certificates as a proof of qualifying pre-requisites, brochures, attested certificates etc.

- a) Valid Copy of shop Act or NOC from Grampanchayat.
- b) Valid registration under GST .
- c) Copy of Pan card.
- d) The agency should have pesticide license from the competent authority for the work under subject. The attested copy of the said license should be submitted.
- e) Work experience of Weed Control chemical Treatment & Rodent control treatment should be available with the agency (not below the rank of Executive Engineer)

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

B. Commercial bid:- Bidder should upload the digitally signed price bid under commercial bid online.

a) Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tenderer fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.

b) This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.

c) The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.

Terms & conditions :

1. The bid validity period should not be less than 90 days from the date of submission of offer.
2. **Work completion Period:** The contract for the period of **3 quarters from from the date of actual start of work at site & after the issue of final work order or exhaust of the total work order amount, whichever is earlier.**
3. **Supervision of Work:-**The concerned Sub Station in-charge of the respective Sub Station is here by appointed as Engineer In charge to supervise. The work will be carried out as per directives of Engineer In charge.
4. The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive of all Taxes. The taxes should be quoted separately.
5. **Security Deposit:** The contractor has to submit, Security Deposit @ of 5% of the total value of the order within 07 days from the date of receipt of the work order in this office by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of the work order and before starting the execution of the work as per work order.
6. **Agreement:-** You have to execute an agreement on Rs.500/- Bond paper after receipt of work order & cost of agreement to be borne by the agency.
7. The T&P/ labour/ machinery/ equipment/ material required for the work shall be on your account.
8. **Execution of work:** In the event of tender being accepted in the whole, the successful tenderer, hereafter referred to as the contractor shall starting execute order immediately as per Annexure 'A' enclosed. The authorized representative of the contractor will visit the site mentioned in Annexure 'A' **at least once in a month and attend the regular work in co-ordination with sub-station in-charge.**

The switchyard should be clean and free from growth of any type of grass, shrubs, weeds etc. The disposal of the grass is to be arranged by the contractor. The removed grass should not be sold. All the activities will have to be carried out in consultation with sub-station in-charge only.

Providing and replacing rat tablets yearly inside of entire control room, battery room,store shed etc. in Substation. Providing chemical powdering in all cable trenches & in all the cable entrance once a year in substation. Providing Antirodent pasting inside entire control room ,store shed etc. in Substations.

9. PENALTY :

- a) **Delay in execution of work :** If the contractor fails to complete the total work in all respect in stipulated time as mentioned above, he will be liable to pay penalty at rate of ½ % per day subject to maximum limit of 10% of the total value of the order.
- b) **Performance of work :** During the contract period , if it is found that performance of work is unsatisfactory, the contract is liable for termination by giving 3 days prior notice and at contractor's entire risk. The security deposit paid by contractor shall be forfeited.
- c) **Delay in starting the work:** If it is found that the contractor fails to execute the agreement/ start the work within stipulated time period, the contract is liable for termination by giving 3 days prior notice and at contractor's entire risk. The EMD paid shall be forfeited.

10. **TERMINATION OF CONTRACT WITH RISK & COST :** If the agency fails to complete the work fully as given in Schedule against the order, within the stipulated period, the Company shall be at liberty, with prior notice of 3 days, to get the work on account of and at the risk of the contractor. MSETCL will prefer a claim for the difference in price and for all expenses whatsoever incurred in getting the same work. The said claim shall be recovered from any payment due to the Contractor from MSETCL , i.e. from bills or deposit or on any account; such expenses will also include 15% Supervision charges. The owner reserves the right to terminate/cancel the contract, in the event of the breach of contract in any respect or undue delay in execution of work/starting of the work.

11. **Tax Invoice:** The Quarterly R.A. bills in triplicate shall be submitted to the Executive Engineer, EHV O&M Division-I, Pune as per Schedule 'A' along with monthly visit report duly certified by operating officer .

The system entries & certification of the work will be carried out by the Engineer-in-charge. After receipt of the bills from the concerned Engineer-in-charge, technical scrutiny & auditing will be carried out at Division Office and payment will be effected accordingly. Please note that the payment will be effected subject to availability of the funds.

12. The monthly visit report duly signed by the Engineer-in-charge & the representative of your office along with the work completion report stating the details of work completed by your office in each quarter (month wise) must be submitted along with the bills.

13. **Payment Terms :** 100% payment will be done after the work completion and on the submission of Tax Invoice as mentioned in Cl above.

14. Any breakage/damage occurred to MSETCL material/ Equipment / theft of material if any, asset during the work shall be recovered from your bills as per rules.

15. The contractor shall not be entitled to claim any interest on amount payable to him.

16. You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereof to any third party. In case any deviations observed it will be treated as breach of contract and the contract will be terminated at your entire risk and cost.

17. You should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.

18. **Income tax:** If applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.

19. In case of difference of opinion, misinterpretation of any of the condition of the contract. In connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.

20. While execution of work, if any loss is caused to MSETCL, the same will be recover from you & you will have to make good the loss, work to be attended by you at your cost & risk only.

21. **Jurisdiction:** All disputes, differences related to the contract shall be subject to the exclusive jurisdiction of Pune District Court.
