<u>Sub</u>: - E-Enquiry for AMC for the Work of Grass Cutting and disposing of Grass buds, thorny bushes etc. Chemical weed control treatment (4 Round) in 400/220/33KV Switch Yard and outside Premises of limited area for Four Quarter at 400KV R/S Deepnagar-BSL-II.

Dear Sir,

Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your rates for the above work. The terms and conditions are as follows.

TERMS AND CONDITIONS

- 1. **Due Date:** The quotation complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dt. 14.12.2021** up to **15:00** Hrs Positively. The quotations will be opened (if possible) on Dt-15-12-2021
- 2. **Enquiry Fees:-** The vendor has to pay Enquiry Fees of **Rs. 100/-** in cash to this office before submission of quotation. The copy of Money Receipt for same attached with the quotation.
- 3. Scope of work: As detailed in schedule' A' Limited to Rs. 7,95,880/-(including GST)
- 4. **Quoted Rates**: The quoted rates should include the cost of taxes. The Taxes will be clearly mentioned, & if the Taxes are not clearly mention, then it will be considered as Inclusive of all taxes.
- 5. For any accident of your staff, public and MSETCL staff while carrying out the work; you will be responsible for any compensation etc.
- 6. If any damage occurs to the company's property during execution of above work, contractor will have to make them good at his cost.
- 7. According to the financial Act 194 (C) OF 1972 income tax will be deducted from your Bill at the applicable rate of the contract value and certificate to that effect will be issued to you.
- 8. **Security Deposit**: The successful contractor shall have to deposit the security deposit of 3% of contract value towards security deposit in this office by Cash/DD/B.G./FDR within 15 days before commencement of the work. The same shall be refunded to you after satisfactorily completion of work and as per availability of funds.
- 9. **Validity of Offer**: The offer should be valid for our acceptance for a period of **90 days** from the due date of same.
- 10. **Period of Contract:-** The period of completion of entire work is **Twelve Months.** However the work is to be completed within stipulated time period as per the instructions of Executive Engineer. In no case the programmed laid down should be delayed.
- 11. **Document required:** The offer rate must be accompanied with following documents duly attested & signed by vender/contractor.

- **1.** The Bidder should have a valid Govt. Electrical Contractor's license for working in Maharashtra state.
- 2. The Bidder should be registered under Goods and Service Tax Act (GST) under GST act
- 3. The Bidder should be registered under P.F. Act
- **4.** The bidder should have labour insurance or Work man compensation policy.
- **5.** Experience Certificate of having successfully completed execution of similar type of work i.e Grass Cutting and disposing of Grass buds, thorny bushes etc., Chemical Weed Control Treatment in MSETCL/MSPGCL/PGCIL/NTPC/Government/Semi Government/ Government Undertaking during last 7 years. Certified by officer not below the rank of E.E. Please enclose the proof of order copy& experience certificate.
- **6.** The Average Annual financial turnover of the bidder during the last 3 financial years should not below than 60% of estimated cost of subject enquiry. If turn over certificate is without UDIN No. then offer is liable for rejection.
- 7. Copy of PAN Card & IT returns of last 3 financial year.
- **8.** Valid Chemical/Pest Control license in his name or agency name issued from agriculture department Govt. of Maharashtra.
- **9.** Proof of valid registration of firm under Bombay shop & Establishment Act/SSI/ NSIC if applicable.
- 12. Undersigned reserves/reserved the right to accept any quotation or to reject all the quotation without assigning any reason.
- 13. For any dispute/differences arises, that will be subjected to jurisdiction of Bhusawal court only.
- 14. The work will have to be carried out for one year from this office intimation otherwise penalty at ½ % per week subjected to maximum 10% of the ordered amount will be levied at the discretion of competent authority.
- 15. Further information required, if any can be had from the Office of the Executive Engineer, 400 kV RS Dn, Deepnagar-BSL-II.
- 16. **Period of work:-** The overall time allowed for completion of the whole i.e. AMC for the Work of Grass Cutting and disposing of Grass buds, thorny bushes etc., Chemical Weed Control Treatment (4 round) fencing to fencing in 400/220/33KV Switch Yard and outside Premises under 400KV R.S. O&M Division, Deepnagar-BSL-II covered under this contract shall be 12 months from the date of handing over of site or work order.
- 17. The agency should be carried out the one rounds in each month or more, as per site condition & requirement hence, it will be responsibility of agency to keep complete 400KV, 220KV &33KV Yard along with the Outside premises free from grass, weed and vegetation throughout the year.
- 18. **Execution & Supervision of work:-** The work shall be supervised jointly by the undersigned & by Add. Executive Engineer (M), appointed by under signed and it should carry out to the satisfaction of Engineer, in charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 19. **Payment Schedule:-** 100% payment against RA bill in each quarter will be paid after satisfactory completion of work time to time as per actual done within reasonable time/period on submission of RA bills in triplicate, certified & recorded in SES by concerned Engineer-Incharge. The payment shall be made to the Agency by NEFT/RTGS only, within 45 days from the date of receiving the bill from the agency by this office.
- 20. **GST TDS:-**As per notification no.50/2018-Central Tax as per Circular-MSETCL/CO/F&A/176 on dt.25.09.2018,GST TDS @ 2% will be deducted from your bills.

- 21. **Labour Cess-** 1% Labourcess under "The building & other construction workers welfare cess Act 1996 & the BOCWWC Rules 1998" will be deducted from your bill as per prevailing rules.
- 22. Quality Of Work& Material:-
 - •The chemicals brought to the site in the form of emulsifiable concentrates used for the treatment should not cause any harm to the human being, and should be kept securely closed and stored carefully. The chemicals should be of approved standard quality. Agency will be responsible for quality of work & workmanship. If the agency fails to correct the problems same shall be treated as unsatisfactory work/service & the work will be carried out from other agency at risk & cost of vendor to which work allotted.
 - •The work includes removal of grown up grass/weed/any type of vegetation from 400/220/33 kV switchyard& Outside premises applying major treatment of chemicals to control the growth of weeds/plants/grass and maintaining entire Switch Yard free from weeds/ plants/grass for a period of one year from the date of handing over of site.
 - •For this necessary chemical treatment is to be given time to time and it is responsibility of the agency to keep the Switch Yard free from grass/weeds/plants etc. for the contractual period and for this agency has to take all possible efforts. All the removed debris (Grass/weeds/plants etc.) should be disposed of& transported as directed by Site In-charge time to time. Dry debris (Removed stuff) should not be stacked stored in substation premises.
- 23. **Termination of Contract:-** If the work is found unsatisfactory/supply is over delayed, MSETCL reserves the right to terminate the contract immediately without entertaining any claim from you in this regard and will be got done through other agency at your cost and risk.
- 24.Bills:- All the payments will be made by Account Payee Cheques only. The agency will have to submit the original bills for supply/works in the name of undersigned to the office of Executive Engineer, 400 kV RS Dn, Deepnagar, BSL-II. The Engineer incharge, Addl. E.E.(Maint.)will verify & records the bills in SES& after verification, the original bills along with SES, NOC, work completion certificate will be sent to the Executive Engineer, 400 kV RS Dn, Deepnagar, BSL-II for further auditing& passing the bills. The Executive Engineer, 400 kV RS Dn, Deepnagar, BSL-II shall make necessary arrangement for effecting of the payment at Division level subject to the availability of funds.
- 25. The workers employed by you for the above work shall not be entitled for any facility/claim from MSETCL what so ever.
- 26.**Precautions:-** All equipments, line & Bus are in charged conditions. Bidder will have to take all precautions at his cost until handing over the site back to MSETCL.
- 27. **Agreement:-** The agency will have to execute an agreement on appropriate value of stamp paper i.e.Rs.500/- as per Mumbai Mudrank Adhiniyam 1955, within 15 days before start of work.
- 28. MSETCL bears no responsibility of any kind in r/o the worker employed for this work & Contractor shall be whole responsible to observe & follow all the statutory provisions regarding Labour laws. The rates should be quoted considering applicability of all these aspects. Thanking you.
