# ANNEXURE (S)

## **TERMS & CONDITION**

#### 1. SCOPE OF WORK:

This tender is for Supply of SF6 gas at various substations under EHV (O&M) Circle, Kalwa as per attached schedule A. Tendered for by the Contractor and accepted by the competent authority, duly authorized in that behalf by the company at rates and delivers to the place at or within the time specified and without any extra charges or expenses to the company whatsoever other than those mentioned in the accepted tender.

#### 2. SPECIFICATION:

The material supplied should be as per the provided specification. If necessary, the material will be subjected to the required test before / after the delivery to insure that it is on our given specification, if the same is not confirming, then the whole lot will be liable for the rejection. The sample should get approved from Executive Engineer, EHV (O&M) Dn, Boisar before delivery & the bulk supply should be as per approved sample only.

## 3. DELIVERY PERIOD

Material should be delivered within 45 days from the date of the receipt of order to "Respective Substation /EHV (O&M) Dn. / as per given allotment at the time of supply ofmaterial". The condition for delivery should be mentioned specifically otherwise, it will be presumed that you will supply the material within stipulated time

### 4. STACKING OF MATERIALS:

The material shall be stacked at approved places only without obstruction to other work and no extra forleads etc. will be admissible for transport of such material to actual place of use.

#### 5. INSPECTION OF MATERIAL:

The material to be supplied will be inspected by the undersigned or his designated representative before dispatch. The agency shall give advance intimation for inspection call. The material shall be dispatched only after approval of the same by inspection report.

# 6. LIQUIDATED DAMAGES:-

- a) If the contractor fails to complete all the works within the time frame stipulated, the MSETCL shall levy liquidated damages for breach of contract.
- b) The Liquidated damage shall be levied at the rate of ½ % (Half Percent) on the delayed portion of contract price per week of delay, subject to the maximum10 % of the contract price for the entire scope of the work.
- c) In case of such delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance work shall be got completed through separate contract at his risk and cost.
- d) GST will be charged @ 18% extra on LD amount calculated

### 7. PACKING, FORWARDING AND TRANSPORTATION:-

- 1) The Contractor shall be fully responsible for Packing, Forwarding and Transportation of material by rail ways or by any other authorized mode of transport, clearance of equipment and further transportation of site place of work / storage yard etc., in respect of material in his scope.
- 2) Contractor wherever applicable shall, after proper painting, pack and crate all equipments / material insuch a manner as to protect them from deterioration and damage during rail / road or any other authorized mode of transfer. The contractor shall be held responsible for all damages / losses.
- 3) The contractor shall notify the Owner of date of each shipment from his / manufacturer works and the expected date of arrival at the site for the information of owner. The contractor shall give all shipping information concerning the weight, size and the contents of each packing including any other information the owner may require.

#### 8. SECURITY DEPOSIT.

The contractor should pay security deposit at the rate of 10% of the value of the order. Security Deposit is payable by FDR. Or Bank Guarantee from a nationalized /scheduled Bank. The S.D. will be refunded after satisfactory completion of the work after completion of guarantee period

#### 9. BILLS:-

All the payments will be made by Account Payee Cheques/Through RTGS only. Tenderer will have to submit the Tax invoice bills in triplicate to concerned Sub-Station Incharge.

#### 10. PAYMENTS:-

100% payment of the contract price will be made on receipt of material by the consignee in good condition, and also after receipt of S.R. Note from the stores/recording of bill by the consignee. The invoice should be submitted to this office in triplicate, along with test certificates (if any)/ Delivery Challan, and advance stamp receipt & along with GSTR1 & GSTR3B copy. Payment will be released by the Superintending Engineer, EHV (O&M) Circle, Kalwa through RTGS within reasonable period.

## 11. FORCE MEASURE:

- A. The following causes that substantially affect the performance of the contract shall only be considered as force measure condition
- i. Natural phenomena including floods, droughts, earthquakes and epidemics.
- ii. Acts of any government, domestic or foreign including war, declared or undeclared, priorities, Quarantines, embargoes. Provided the party affected by the "force Measure" shall within fifteen (15) days from the occurrence of such a case, notify the other party in writing of such cause with sufficient documentary proof.
- 12. The Income Tax & Labour cess at the rate applicable will be recovered from your bills.
- 13. All royalties and all local and other Taxes/duties/cess etc, shall be paid by the Contractor at his cost.
- 14. If the Contractor fails to execute the work, it will be treated as breach of contract & contract will be terminated and order will be cancelled by forfeiting the EMD/security deposit.

#### 15. APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:

Notwithstanding anything stated here, the MSETCL's General Terms & Conditions of Contract shall be applicable to the contract as far as they are applicable to your contract.

#### 16. QUALITY OF WORK :-

The material should be supplied as per specifications mentioned in Schedule 'A'. The sample should be got approved from Executive Engineer 400kV R S Dn., Kalwa for procurement of material as per Schedule A before delivery.

#### 17. JURISDICTION:

All the disputes arising out of this contract shall have exclusive jurisdiction of court in Thane.
