Pre-qualifying requirement:

The vendor must possess the following documents and they should essentially submit Original scanned copies of the documents along with the Technical Bid. The Xerox copies of documents will not be considered valid for e quotation & the vendor will be dis-qualified.

- Valid certificate of registration of appropriate class from PWD / MES / Railways / Jeevan Pradhikaran / MAHAGENCO / MAHATRANSCO / MAHADISCOM / ETC OR from any Government / Semi Government / Central Government/ Bombay Shop Act Registration
- 2. G.S.T. registration certificate.
- 3. PAN card & Income Tax Clearance Certificate/ Acknowledgements of Income tax returns filed (last financial years) in the name of firm.
- 4. Valid Experience Certificate (If any.)
- 5. Valid documents of vehicles as per the provision of Motor vehicle Act such as
  - (a) Registration Certificate
  - (b) Tax clearance certificate/ Tax paid receipts
  - (c) Insurance
  - (d) Passing and Fitness Certificate
  - (e) PUC
  - (f) T permit/ school permit
  - (g) Documents required as per the Motor vehicle Act latest revision, remained if any
  - (h) Driving License

## Terms & Conditions :

1. The time limit allowed for completion of the above work is 313 **Days** from the date of handing over of site / issue of order, failing which the contractors shall be liable to pay as compensation an amount equal to one percent of the cost of whole work or such smaller amount of work as per discretion of the competent authority, everyday that of work remains uncompleted or un finished after due date of completion subject to maximum of 10 percent of the cost of order and / or the work shall be carried out at your risk through any other agency.

- 2. The quantities mentioned in the attached schedule "B" are approximate and may vary during the course of execution. Contractor will have no claim for the alteration. However, payment will be effected as per the actual measurements, measured at site as per M.S.E.T.C.L.'s rules.
- 3. Quoted rates should be firm and should include all charges such as duties, all types of taxes, Insurance, labour cess, tolls etc. complete. Nothing extra will be paid on any account over the quoted rates.
- 4. The work should be carried out as per the standard specification mentioned in the latest edition of the PWD specification booklet & to the satisfaction of the Engineer in-charge.
- 5. No material shall be supplied by the Department & all tools & plants required for the work shall be contractor's own.
- 6. Contractor will have to make good damages, if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 7. Contractor will be responsible for any type of accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing "Workman's Compensation Act"
- 8. Contractor will have to pay earnest money deposit online.
- 9. Contractor will have to pay Security deposit in cash at the office of Superintending Engineer, HVDC R.S.(O&M) Circle, MSETCL .Padgha or in the form of Demand Draft / F.D.R. of any schedule bank drawn in favour of "MSETCL, Padgha" payable at Padghe only equal to 5 percent of the value of the order and submit the same to this office within seven days from the date of receipt of work order or same will be deducted from your bill.
- 10. Payment will be made by this office in the form of First & Final Bill or R. A. Bills at the discretion of undersigned, within a reasonable period on submission of bill in triplicate to this office.
- 11. Whenever there is paucity of funds, the priority of payments of bills of various agencies will be decided by the undersigned and all the rights in this regards are reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest / compensation due to delay in their payments of bills on account of paucity of funds.
- 12. **Income tax, Insurance, Labour cess, G.S.T.** as applicable will be recovered from the bill on the total value of the work done as per the prevailing rates for which necessary certificate will be issued from this office.
- 13. The terms & conditions enumerated in the approved booklet "TENDER & CONTRACT FOR WORKS" will be applied in this case and will be binding on the contractor entirely.
- 14. The offer quoted for this quotation shall be valid for **120 days** period from the due dated of submission of the quotation.
- 15. In addition to above the condition, Standard terms and condition of MSETCL's shall also applicable.
- 16. Right to reject any or all quotations without assigning any reason is reserved by the undersigned.
