Sealed and super scribed uniform percentage rate quotation are invited the above mentioned work as detailed in "Schedule -B," attached herewith so as to reach the office of the undersigned at the above mentioned address on or before 11/03/2022 up to 15.00 Hrs.

(a) Compulsory Primary Documents in 1st Envelop:(Technical Bid)

- (i) Valid Certificate of Registration of appropriate class for Civil works from PWD /MES/ Railways/ Jeevan Pradhikaran ETC.OR From Any Govt. / Central Government.
- (ii) GST/ GSTIN Registration Certificate.
- (iii) PAN Card.
- (iv) E.P.F. Registration Certificate issued by competent authority of Govt.
- (v) Experience of having successfully completed civil works.
- (vi) Contractor will have to pay E.M.D of Rs. 500.00 only in the form of Cash or D.D. of any Schedule Bank in the name of Executive Engineer (C), EHV CCCM Division, Nashik Maharashtra State Transmission Company Ltd. Or in Cash in this office up to 14.00 Hrs. during working days. Quotations submitted without the payment of E.M.D shall be liable for rejection. The envelopes of the Quotations should be super scribed about name of work, D.D. No. OR M.R. No. of the E.M.D & having registered vendor of MSETCL.

(b) Documents in 2nd Envelop:(Price Bid)

i) Price bid only where in the rates/percentage should be quoted in figures as well as in words.

OTHER TERMS AND CONDITIONS

- 1) Rates quoted shall be inclusive of dismantling & disposing off all material/debris of staff quarter buildings (Class-III & Class-IV) and disposing off all debris outside the premises of 132 KV Yeola sub station (as mentioned in schedule) Transportation, Loading, Unloading and other incidental charges. Nothing extra on any account will be paid.
- 2) No material shall be issued by the department.
- 3) All T&P, Labour, Water etc will have to be arranged by the Contractor at their own cost.
- 4) Work shall be done within 15 Days from receipt of Work order/handing over of site, failing which penalty at the rate of ½ % per week to maximum upto 5% of work order will be levied and recovered from deposited amount.
- 5) If any damage occurs to the Company's property during execution, contractor will have to make it good at his own cost and risk.
- 6) If any accident occurs to contractor's labours during the execution of work, the Company will not be responsible for the payment of any compensation of them. In such cases, it will be the contractor's responsibility to pay the compensation as per the Workmen compensation act and the rules made there under.
- 7) The terms &conditions enumerated in the approved Booklet "TENDER AND CONTRACTOR FOR WORKS" will be applied in this case & will be binding on the contractor entirely.
- 8) Right to reject any or all quotations is reserved by the undersigned.
- 9) The rates quoted will be valid for 90 days from the date of opening of quotation.
- 10) In case of any disputes, the work order for this work shall be final and binding on contractor.
- 11) In case of any disputes, the work order for this work shall be subject to Nashik Court/ Mumbai High Court's jurisdiction only.
- 12) Contractors are requested to inspect the site of work before submitting the quotation. Tax Act 1961, applicable to agency.
- 13) Price variation & price Escalation: No Price escalations clause is applicable for this work.

14) Deposition of work amount:-

Contractor has to pay amount as per quoted by the agency over total estimated amount of Rs. 6900/- (i.e. Excluding GST) which is non refundable. Further, contractor has to deposit Rs. 50000/- SD against this work to this office within 07 days prior to commencement of work or as directed before placing the work order.

- 15) No T&P shall be provided by the company.
- 16) If the agency intends to use the electricity from the company the amount of 0.25% the work order shall be deposited separately in this office or deduction will be made as per actual consumption whichever as applicable.
- 17) The agency will be sole responsible for any mishap, accidents, loss, damage, etc happens during the work to other asset or his labours.
- 18) The agency shall abide by any/all laws relating to labour, work, transportation, etc.
- 19) GST: GST will be applicable as per prevailing rules of Govt.
