 - (d) The bidder should have experience execution of similar type of order in MSETCL OR GOVT. undertaking OR government organizations/power sector during last 7 years. The bidder should submit the following documents
 - (e) Bidder should submit the Make, Model nos and photographs for all mention items in schedule (if any make model requirement to MSETCL shall be provide by you.
 - (f) The bidder should submit the shop act certificate
- 2. Quotations with incomplete details or not submitted in due date etc. are liable to reject.
- 3. This office reserves all the rights to reject any or all quotations without assigning any reasons thereof.
- 4. Rates quoted shall be inclusive of all taxes, Transportation, Loading, Unloading and other incidental charges. Nothing extra on any account will be paid.
- 5. Quantities mentioned in schedule A are approximate and may vary. However, the payment will be affected on the basis of actual quantity executed.
- 6. No material will be issued by the Company.
- 7. Completion period is 20days including supply and installation of material at respective site.
- 8. If any damage occurs to the Company's property during execution, contractors will have to make it good at his own cost.
- 9. If any accident occurs to contractor's personnel during the execution of work, the company will not be responsible for the payment of any compensation to them. In such cases, it will be the contractor's responsibility to pay the compensation as per the workmen Compensation act and the rules made under.
- 10. You have to remit, Security Deposit @ 10% of the total value of the order in this office by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of order & before execution of work. If you fail to do so, the SD will be recovered from your first bill with interest. The S.D. will be refunded after the completion of guarantee period.

11. If you fail to execute work within stipulated Time, penalty @ 1/2% per week, maximum to 10% of order amount shall be levied on contract value & GST applicable on LD amount.

12. You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereof to any third party. In case any deviations observed it will be treated as breach of contract

and the contract will be terminated at your entire risk and cost.

13. You should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also. 
