Circle, New Admin Bldg-103, 132 KV S/Stn.Harsool Premises, Sillod Road Near Harsool T-Point, Aurangabad Dist:Aurangabad -431008 on or before **dtd.30.03.2022 up to 18.00 hrs.**

TERMS AND CONDITIONS:-

1. Contractor shall submit duly filled quotation in sealed envelope with name of the work, EMD transaction no, name of agency written on envelope, address of vendor and stamp. The Contractor shall submit GST Certificate if applicable, PAN No etc. Quotations received after due date (and time) will not be considered and this office is not responsible for any postal delay.
2. Time limit for the work is 1 (one) month. Earlier work completion will be appreciated.
3. Total Security Deposit : Within 7 days from the date of issue of letter of intent/ work order, you will pay security deposit as prescribed in work order in the office of the Superintending Engineer (Civil), EHV CCCM Circle Aurangabad. The Security Deposit amounting 5 % of work order value in form of cash or Demand Draft or fixed Deposit receipt of Bank Grantee in company's standard proforma. The Demand Draft/ FDR shall be drawn in favor of the Superintending Engineer (Civil), EHV CCCM Circle Aurangabad by Nationalized / Scheduled Bank.
4. The contractor has to pay EMD of Rs 1500/- in the form of NEFT/ DD of any Nationalized Bank in favor of Superintending Engineer (Civil) EHV CCCM Circle, MSETCL Ltd. Aurangabad. The DD of required amount if not found in the envelop the quotation will be rejected.
5. Refund of security deposit: Total security deposit shall be refunded to the contractor in spite of any delay in the finalizing of the final bill within a month from the date of expiry of maintenance period, provided that all works under the contract shall have been completed satisfactorily by the contractor.
6. The maintenance period will be of 2 (Two year).
7. The rates should be valid for 120 days.
8. The quantities mentioned in Schedule 'B' are tentative. There may alteration/deletion of quantities as per requirement. The rates shall be quoted in the work schedule "B" The rates and amount shall be written both in words and figures. The rates shall be written legibly and shall be free from eraser. Overwriting or conversions of figures correction and where unavoidable shall be made by Crossing out initiating, dating and rewriting.


9. No labor assistance and T&P will be provided by the company.
10. Offer should be quoted on the 'Schedule B' attached with the enquiry.
11. Work is to executed at office of Superintending Engineer (C), EHV Civil Constn. Cum Maint. Circle, New Admin Bldg-103, 132 KV S/Stn.Harsool Premises, Sillod Road Near Harsool T-Point, Aurangabad Dist: Auarangabad. No Extra transportation and labor charges, insurance charges will be paid.
12. No advance payment shall be made in any case. However, 100% payment shall be effected after satisfactory completion of work.
13. The terms and conditions stipulated in Company Booklet of tender and contract for such type of work will be applicable for your contract also.
14. The quotation should be submitted strictly as per our requirement; any additional condition/shortfall left in offer letter shall cause rejection of quotation.
15. The undersigned reserves the right to reject any or all the quotations without assigning any reasons thereof.
16. Rates to be quoted including all taxes,transportation,lead, taxes, insurance.
17. Agreement on bond of Rs.500/- shall be executed by you at your own cost within 7 days from receiving work order.
18. The Contractor will have to make good the damages if any made by him during the execution of work at his own cost.
19. Income Tax as per the prevailing income Tax rule and subsequent amendment thereof will be deducted at source of your bill on total value of work done for which the certificate will be issued if desired
20. Contractor will be held responsible for accident occurred during the course of the work and will have to pay the compensation as per the act 1923 and subsequent amendment thereof.
21. GST will be deducted from Contractor bill at prevailing rate as per GST norms.
