The quotation should reach this office on or before 11.05.2022 up to 12:00Hrs. The estimated cost of work is Rs. **5,06,277.00/-**.

**TERMS & CONDITIONS: -**

1. The rates should be quoted in schedule 'A' will be firm and inclusive of all taxes & duties. The taxes amount shall also be mentioned separately.
2. Your quotation in a sealed envelope super scribed with above enquiry number & date & all required documents and should reach to this office from 03.05.2022 to 11.05.2022 up to 12:00Hrs. positively.
3. Validity period for rates quoted should not be less than 90 days from the date of receipt of the quotation.
4. Quotation should be duly filled & signed in all respect otherwise it will not be considered.
5. In case of any dispute, decision of the Executive Engineer, E.H.V. Projects Dn. Kalyan shall be final and binding on the contractor.
6. You have to produced following document at the time of submission of quotation.
  - a) Registration under Bombay Shop act
  - b) Certificate of Registration under GST registration if applicable
  - c) Pan card
  - d) ITR of last three assessment year (2019-20,2020-21,2021-22)

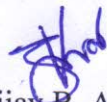


7. You have to pay Security deposit of Rs.25315/- i.e. 5% of the order value in the form of D.D./BG drawn in favour of "M.S.E.T.C.L." payable at Kalyan within Seven days from the date of receipt of order.
8. Work completion period:- The period of this contract is twelve months from the date of issue of the order or maximum financial limit of Rs. 5,06,277/- only (Including 5% GST) whichever is earlier.
9. The bidder has to provide the service of packing of material as and when required and as per instruction of subdivision incharge.

**10. Bill :-**

- a) The bill in triplicate should be submitted through Concerned Sub divisions & payment will be made subject to the submission of bills with required documents from you and certified by Engineer in charge. Executive Engineer, EHV Projects Dn, Kalyan will make arrangement of payment.
- b) The Income Tax, Labour cess, Goods & Service Tax at the rate applicable will be recovered from your bills, if applicable.
- c) All royalties and all local and other Taxes/duties etc shall be paid by the Contractor at his cost.
- d) In case of such delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance work, if any shall be got completed through separate contract at the risk and cost of the tenderer.**
11. The work should be carried out as per standard and to the satisfaction of the Engineer-In-charge.
12. All tools & plants required for the work shall be arranged by contractor at his own cost.
13. The work shall be supervised by Addl Ex. Engr., Special Projects team. Kalyan. The contractor should obtain a certificate from concerned Sub divisions for execution of work satisfactorily.
14. The quoted rates should be firm and should include all such as duties, all type of taxes etc. Also mention the SAP vendor number on quotation.
