 - e. Undertaking for submission of Labors Contract License if work is allotted and more than prescribed number of employee are employed by agency.
 - f. Income Tax Returns for last years with PAN Card Copy.
 - g. Experience certificate from the officer not blow the rank of Executive Engineer for successfully executed maintenance work on EHV line in MSETCL.
 - h. Duly signed Annexure-A with declaration from contractor.
