- 6. GST, Duties, Taxes, Cess, Royalties etc will be recovered from bill, as applicable.
- 7. Enclose duly attested & signed copies of following valid documents, along with quotations:
  - a. Proof of Registration of firm under Bombay shop & Establishment Act/ SSI Certificate /Certificate under Company's Act.
  - b. Proof of valid Electrical Contractor License.
  - c. Proof of GST Registration.
  - d. Valid Workman Compensation Policy.
  - e. Undertaking for submission of Labors Contract License if work is allotted and more than prescribed number of employee are employed by agency.
  - f. Income Tax Returns for last years with PAN Card Copy.
  - g. Experience certificate from the officer not blow the rank of Executive Engineer for successfully executed similar type of work.

- h. Duly signed Annexure-A with declaration from contractor.
