- 2] ✓ The prescribed form i.e Schedule 'A' duly filled in with the rates written in words and figures and signed should be sent by Registered post or in person to The Executive Engineer EHV O&M Division, Dombivali.
- 3] ✓ Please Super scribe the offer with the following details :-

- 4] ✓ Quotations which do not fulfill all or any of the qualifying conditions or are incomplete in any respect are liable to be rejected.
- 5] ✓ Bidder should not submit "Conditional Quotations"; Such conditional offer shall liable for rejection.
- 6] ✓ Payment : Payment will be made by the EHV O&M Dn Dombivali within reasonable time after completion of the work satisfactory in each month and on receipt of your bill in triplicate and certificate obtaining from the Engineer incharge for the work executed.
- 7] ✓ In case of any dispute regarding any clause of the work order or works, the decision of the undersigned will be final and binding on you.
- 8] ✓ You should not affect the transfer of work or any part of it to any other agency.
- 9] ✓ You will be cover under standard terms and condition contained in MSETCL tender and contract for the works.
- 10] ✓ Jurisdiction : The jurisdiction of all legal proceedings / suits as regards to the works under contract will be under Thane District Court.
- 11] ✓ Tax deduction at source: In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. Similarly any other tax deductible at source, if applicable to this particular contract, as per statutory (laid down by Central or State Government), will also be deducted from the bills at the prevailing rates.
- 12] ✓ Security Deposit: The successful bidder should pay security deposit at the rate of 5 % of the oorder value within 15 days from the date of receipt of order, in the office of the Executive Engineer EHV O&M Division, Dombivali in form of Cheque / DD/BG/FDR of Nationalized Bank or Schedule Bank which will be refunded after 1 year after completion of work successfully or completion of guarantee period.
