- 4) The average consumption of the vehicle given on hire basis should be minimum 15 km/liter irrespective of actual average of the vehicle. If the average consumption is less the proportionate amount will be deducted from your bills on the calculation of the km run.
- 5) All the maintenance charges of the vehicle, driver salary, overtime allowance and other benefits of the driver will have to be borne by you.
- 6) All valid RTO related documents such as Tourist Permit. RC, TC book, fitness certificate, insurance etc. should be submitted along with the quotation.
- 7) Only diesel will be supplied by MSETCL. The engine oil and lubricants, repair of vehicle, driver salary will be arranged by you at your cost.
- 8) The driver of vehicle must have valid license from RTO authorities, further he must be polite, obedient, punctual and without ill habits.
- 9) Total Aurangabad Zone area i.e. Marathwada region of eight districts is under jurisdiction of this office. So vehicle should be made available for tours of said area as and when required.
- 10) The vehicle should be made available at any time in any day.
- 11) The quotation should reach this office on or before 11/07/2022.
