1	Hiring of 17/14 seater school bus (recognized and approved by RTO authority) for the wards of MSETCL staff/ employees residing at 220kV S/Stn colony and 400kV R.S. colony staff quarters. The services to provide pick up and drop facility to the students from those residential colony to nearby areas located with schools/ colleges. The services are required for daily basis and the particulars viz list of the students/ distance required to travel per day/ number of trip required per day shall be as per the instructions of the concerned in-charge. The rate is inclusive of fuel and all other overheads required to run the vehicle.	Per Day	

1) <u>DUE DATE: -</u> The quotations complete in all respects, duly sealed & super scribed should be submitted to this office <u>from 13.07.2022 to 20.07.2022 up to 13:00 Hrs positively</u>.

2) <u>QUOTED RATES:</u> - Taxes & Charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.

3) <u>SCURITY DEPOSIT: -</u> The successful bidder will have to pay 5% of total work order value towards S.D. at EHV (O&M) Division Office Babhaleshwar.

4) **<u>VALIDITY OF OFFER:</u>** The offer should be valid for our acceptance for a period of 1 year from the Due date of same.

5) The rates should quote on per day basis including cost of fuel.

6) No extra charges will be paid for vehicle driver, repairs, oil & all other expenses including accidental damages if any.

7) The vehicle should be in good condition & not more than 05 year old (i.e. manufacturing year of vehicle shall be July-2017 onwards & the vehicle prior to year July- 2017 will not considered),

8) The vehicle should have valid T permit.

9) The period for hiring of vehicle will normally be 12 months from the date of engagement of vehicle, however if MSETCL vehicle is allotted by C.O Mumbai the hired vehicle will be discontinued by giving 15 days notice.

10) Bidders have to pay enquiry fee Rs.118/- (Including GST) and submit the original money receipt along with quotation

11) The responsibility of comprehensive insurance, PUC, tax permit & RTO formalities will be with vehicle provider.

12) Separate vehicle diary/Logbook will be maintained by the contractor for the account of diesel Km. run/day etc. for hired vehicle.

13) Payment will be effected on per month basis within reasonable period after recording in Measurement Book by concern officer Incharge.

14) Quotation must be submitted along with the attested Xerox copies of all the documents pertaining to the vehicle such as i) Vehicle registration documents ii) Vehicle Fitness Certificate iii) Valid vehicle Insurance iv) Valid 'T' permit, v) Valid PUC vi)Driving License etc. vii) PAN Card copy.

15) The vehicle must be in the name of bidder/owner if not the owner must give declaration that he has permitted the bidder to rent out the said vehicle.

16) Notwithstanding anything contained herein the Company's general terms and conditions of contract shall be applicable to this contract.
